Monday, April 21st

First day early/absentee ballots can be mailed to voters.

Monday, April 21st

First day a voter can vote at the election office.

Last day to register to vote at election office by 6:00p.m. Last day to request a mail ballot be sent to your home. Deadline is 6:00p.m.

Election Day! Last day to return your ballot. Your ballot must be received by 8:00p.m. election day.

Political Party and Candidate Information

Political parties are invited to submit a statement that argues for the success of their principles and the election of their candidates. These statements may also oppose the principles and candidates of other political parties or organizations. Candidates are invited to submit a statement explaining their views, goals, or qualifications for office.

Statements are printed as received, with only minor formatting adjustments for consistency and clarity.

The following political parties did not submit a statement for the 2025 Lincoln City General Election:

- Legal Marijuana NOW
- Lancaster County Republican Party

Candidate names will also appear without a statement if they did not submit one by the deadline.

Voter Registration Information

Who Can Register to Vote?

To register you must be:

- A United States Citizen
- A resident of Nebraska
- At least 18 years old; or if you will be 18 years old on or before November 4, 2025

Mentally Incompetent

If you have been found by a court to be mentally incompetent, you cannot register to vote.

Where Do I Register to Vote?

- In person at the Election Office, 601 N 46th St., Lincoln, NE 68503.
 - » Regular Lancaster county office hours are Monday through Friday, 8:00a.m. to 4:30p.m.
- Online at nebraska.gov/apps-sos-voter-registration
- Through the Department of Motor Vehicles when you obtain or update your Nebraska driver license or state identification card.
- When applying for benefits through the State Department of Education or Department of Health and Human Services.
- Paper copies of the voter registration application are available. Those forms will need to be completed and returned to the Election Office. Registration applications are available at:

When Do I need to Update my Voter Registration?

You must update your voter registration if you change:

- Your Name
- Address
- Political Party Affiliation

What are the Voter Registration Deadlines Before an Election?

- Mail-in registration applications must be postmarked no later than Friday, April 18th.
- When registering to vote through the DMV or another state agency, the application must be completed no later than Friday, April 18th.
- Online registration applications must be submitted before midnight on Friday, April 18th.
- In-person at the Election Office until 6:00p.m. on Friday, April 25th.

Am I Required to Choose a Political Party when I Register to Vote?

- You must choose a political party if you wish to vote for partisan candidates in a partisan primary election.
- Choose to register as "Nonpartisan" if you do not wish to vote for partisan candidates in a partisan primary election.
- Nonpartisan registrants may be eligible to vote on partisan ballots for certain established parties, depending on primary rules.

How is Residence Determined?

- Your residence is considered the place where you have established a "home." It is the place that, when you depart, you intend to return.
- For voting purposes, if you leave your "home" for military service or school/college, you are allowed to maintain your "home" as your voting residence. However, if you choose, you may change your voter registration to the location of your military assignment or school.

Do I Have to be a Resident for a Certain Amount of Time to Register?

• No. You may register to vote the same day you move to Lancaster County.

Will I Receive Notice that my Registration Application has been Accepted and Processed?

- Yes. When you register to vote, an informational postcard will be mailed to you within 10 days.
- The postcard will inform you of the location of your polling place and some of your voting districts.


Felony Conviction

In October 2024, the Nebraska Supreme Court ruled that Nebraskans with felony convictions who have completed their sentences can immediately register to vote, upholding Legislative Bill 20 (LB20). This decision overturned a directive from the Secretary of State that had blocked voter registrations.

If you have completed all terms of your felony sentence, you are eligible to register to vote and cast a ballot in the 2025 Lincoln City elections. Nebraska law allows individuals with felony convictions to register to vote immediately after completing their sentence, including any parole or probation. To vote in the upcoming election, be sure to register before the deadline and check your voter registration status with your local election office.

Early Vote/Absentee Vote Deadlines 2025


- You may apply for an early/absentee ballot
- Early vote/absentee ballots will be mailed to voters on Monday, April 21st
- Voters can vote at the Election Office beginning Monday, April 21st
- The last day to vote at the Election Office is Monday, May 5th

How do I submit my completed Early Vote/Absentee application?

- Mail or in-person: Election Office, 601 N. 46th St., Lincoln, NE 68503

- Drop box: Drop boxes are available at several locations, and no postage is required if you use them or hand-deliver your application. These locations include the Election Office (on the north side of the building) and four libraries with 24/7 drop boxes: Anderson Library (Fremont & Touzalin), Eiseley Library (15th & Superior), Gere Library (56th & Normal), and Walt Library (14th St, between Old Cheney & Pine Lake).

How can I return my voted Early Vote/Absentee ballot?

- U.S. Postal Service; your ballot must be received by 8:00p.m. on election day
- Hand-deliver to the Election Office, 601 N. 46th St., Lincoln by 8:00p.m. on Election Day.
- A drop box is located on the north side of the Election Office.
- Early Vote/Absentee Ballots cannot be returned to a polling location on Election Day.



In-Person at Your Polling Place on Election Day

When will the polling place be open on Election Day?

• The polls are open from 8:00 a.m. to 8:00 p.m.

Where do I vote?

 You must cast your ballot at your assigned polling place. If you do not know the location of your polling place, call the Election Office at (402) 441-7311 or log on to <u>votercheck.necvr.ne.gov</u> and click on "Polling Place".

Do I need to present a voting card or other ID to vote?

• Yes. Identification is required to vote.



Voting Accessibility for Individuals with Disabilities in Nebraska

The Help America Vote Act mandates states to enable voters with disabilities to cast independent and confidential ballots. Nebraska implemented measures to accommodate various disabilities including visual and hearing impairments, limited mobility, and manual dexterity issues. For the 2025 elections, all polling places are equipped with ExpressVote machines.

The ExpressVote facilitates private and independent ballot marking with features such as:

- Audio function with headset for visually impaired voters.
- Zoom option to enlarge text size on the ballot.
- · Support for sip/puff tubes for those unable to use touchscreens.
- Ability to vote for write-in candidates.

Accessibility Standards for All Nebraska Polling Places

Nebraska enforces ADA standards for polling place accessibility. Requirements encompass parking, pathways, entrances, voting areas, and assistance. Parking areas must have van-accessible spaces, accessible pathways must be unobstructed, and entrances should be step-free or have ADA-approved ramps. Voting areas must include at least one accessible booth and an ExpressVote machine.

Services for Voters with Special Needs

Nebraska provides accessible voting options, including:

- Early in-person voting at county offices.
- Ballot delivery to homes, hospitals, or care facilities.
- Assistance from election officials or a chosen friend.
- Curbside voting for those unable to enter the polling place.
- TTY service for voters with hearing impairments.

Additional Assistance Available at Nebraska Polling Places

Nebraska polling places offer:

- Clear voter instructions.
- Help from Receiving Board judges.
- Magnifiers and signature guides.
- Seating for voters who need it.
- Materials for speech or hearing impaired voters.
- Prompts to request assistance.
- Curbside voting with bipartisan support.

Voter ID

All Nebraska voters are required to present an acceptable form of photo identification when voting in person.

Acceptable Forms of Photo ID

Nebraska law allows voters to present any of the following valid or expired photo IDs:

- Nebraska Driver's License or State ID
- U.S. Passport
- Military ID (Department of Defense or Veterans Affairs)
- Tribal ID (Issued by a recognized Native American tribe)
- Nebraska College or University ID (Public or private institutions)
- Nebraska Political Subdivision ID (State, county, city, or public school-issued)
- Hospital, Assisted-Living Facility, or Nursing Home Record (With name and photograph)

Expired IDs are acceptable, as long as they include your name and photo.

How to Get a Free ID

Nebraska provides free state IDs for voters who need them:

- Visit the Nebraska DMV and apply for a free State ID for voting purposes (bring proof of identity and address).
- If you need a birth certificate to obtain an ID, you can request a free certified copy from the Nebraska Department of Health and Human Services only for voting purposes.

Reasonable Impediment Certification (RIC)

If a voter **cannot obtain an acceptable photo ID**, they may **vote provisionally** by completing a **Reasonable Impediment Certification (RIC)**. Valid reasons include:

- Disability or illness preventing the voter from obtaining valid photo identification
- Lack of required documents (e.g., birth certificate) and an inability to obtain them without significant difficulty or expense
- Religious objection to being photographed

Voters using an RIC must vote provisionally. Their ballot will be counted if they complete and sign the RIC form and the signature matches their voter registration.

How Voter ID Works in Different Voting Methods

Voting in Person (at the polls or election office)

- Present an acceptable photo ID OR
- Complete a Reasonable Impediment Certification OR
- Vote provisionally

Voting Early by Mail

- Write driver's license or state ID number on the early voting application OR
- Enclose a photocopy of an acceptable ID OR
- Enclose a photocopy of the Reasonable Impediment Certification

Voting in By-Mail Precincts or Special By-Mail Elections

- Write driver's license or state ID number on the ballot return envelope OR
- Enclose a photocopy of an acceptable ID OR
- Enclose a photocopy of the Reasonable Impediment Certification

About the City Council Election

All three City Council seats on the ballot are **At-Large**, meaning all residents of Lincoln may vote for up to three candidates.

The top three candidates receiving the most votes citywide will be elected.

Important: If a voter selects four or more candidates, the City Council portion of the ballot will not be counted.

Voters may request a replacement ballot from the Lancaster County Election Commission if needed.

Lancaster County Libertarian Party

The objective of the Libertarian Party is to maximize individual liberty. While it is a coalition comprising people of various beliefs, it is founded on a common core set of libertarian principles. At the foundation is the Non-Aggression Principle: none shall initiate aggression upon another except in defense of oneself or one's property. From this, many positions, such as those on property rights, gun rights, etc., can be deduced. Other important principles are freedom of speech, right to free association, and self-determination. In addition, libertarians are informed on practical matters through the works of the Austrian economists, such as Ludwig von Mises and Murray Rothbard. The principles developed by these thinkers form a logical framework essential to understanding human action—the basis of any economic system. These principles are the foundation on which libertarians' economic positions are formed, such as those on taxation, regulations, etc. For more info, visit nelclp.org or Ipne.org. While libertarians may vary on particulars, the following are typical positions:

Minimize government: The government is founded purely upon aggression and coercion, and any service it provides can be provided by the free market more efficiently. Thus, the size of the government at all levels should be reduced, although the desired size by any particular libertarian may vary from small to zero.

Reduce taxes: The government can only exist through coercive seizure of private property—taxation. Not only is this a violation of the Non-Aggression Principle, practically it is a pure harm upon the economy. Thus, taxation should be reduced across the board; some believe it should be eliminated entirely. Think of the absurdity of having to pay the government to live on one's own property.

Eliminate regulations: The government harms the economy not only through taxation; it prohibits mutually beneficial transactions from taking place through regulations. Not only is this intrusion morally abhorrent, bureaucratic restrictions placed by the government stifle economic growth and therefore tend to reduce the standard of living. For example, minimum wage laws and price fixing fall into this category and should be eliminated.

Abolish subsidies: A wrong is already committed when the government forcibly takes money through taxation; a further infraction occurs when it then hands some of this money to certain favored entities in particular industries through subsidies. Practically, this distorts the price structure in the economy, misleading entrepreneurs and disrupting economic activity. Thus, all subsidies must be abolished, whether they be farm or child care subsidies.

Cut welfare: Every individual is responsible for one's own well-being and cannot demand financial tribute from another. Much like subsidies, government welfare is simply a way to take from the taxpayer to give to some specific favored group—income redistribution. Food stamps, unemployment benefits, and social security, to name a few, fall into this category and should be cut.

Legalize drugs: One ought to be allowed to use any substance whatsoever. In practice prohibition has only fueled criminal activity, harming society rather than improving it. However, this is not an endorsement of drug use; like all other aspects of adult life, one must understand the risks and take responsibility accordingly.

Repeal Gun Laws: An armed populace cannot be easily subdued by the government. This is why under the guise of "public safety," the government wishes to restrict our gun rights, undermining our ability to defend ourselves. Every single gun law is an infringement and should be repealed. Certain laws that uphold our rights are supported, such as Constitutional Carry.

End foreign wars: Engaging in conflicts in foreign countries not only invites animosity against us, it prompts the government to direct scarce resources toward war production. This lowers our living standards to the benefit of the war industry and their puppet politicians, not to mention the human costs of unnecessary destruction. War also brings severe restrictions on individual liberty under the guise of "national security."

Support sound money: Whenever the government spends more than it takes through taxes, it makes up the difference by having the Federal Reserve print money for itself and its cronies. The end result is higher prices for all of us. Sound money free from government counterfeiting operations is essential for a properly functioning free society.



Ballot Issues

Initiative Petition to Amend the Lincoln Housing Code (Title 11) to Add Protections for Lawful Sources of Income.

Initiative summary: This proposal would make it illegal for landlords or sellers to refuse to rent or sell housing in Lincoln based on a person's legal source of income, such as wages, child support, or housing vouchers.

The following is the full ballot ordinance language as it will appear for voters:

Shall Title 11 of the Lincoln Municipal Code (LMC) be amended to prohibit discrimination in renting or buying housing in the City of Lincoln on the basis of a person's lawful source of income; to provide a definition of lawful source of income; to specify certain unlawful discriminatory acts; and to establish related administration and enforcement powers. Specifically:

Lawful source of income shall mean any lawful and verifiable source of money paid to or on behalf of a renter or buyer of housing, including any related program requirements. Lawful sources of income include but are not limited to:

(1) Income from a lawful profession, occupation, or job;

(2) Income derived from Social Security or any form of federal, state, or local public assistance or housing assistance, including a housing choice voucher issued pursuant to Section 8 of the United States Housing Act of 1937, whether or not such income is paid or attributed directly to a landlord, and even if such income includes additional federal, state, or local requirements; or

(3) A pension, annuity, alimony, child support, foster care subsidies, or any other recurring, lawful, and verifiable monetary consideration or benefit.

Grant the Commission on Human Rights for the City of Lincoln the power to investigate complaints in housing based on lawful source of income, under LMC 11.02.040.

Prohibit as unlawful, under LMC 11.06.020 and 11.06.065:

(1) the refusal to show, negotiate, receive an offer, or sell or rent a dwelling because of a person's lawful source of income;

(2) discrimination against any person in the terms and conditions of sale or rental of a dwelling because of a person's lawful source of income;

(3) the making, printing, or publishing of any notice or advertisement indicating preference, limitation or discrimination on the basis of a person's lawful source of income;

(4) representing to any person because of lawful source of income that any dwelling is not available for inspection, sale, or rental, when such dwelling is, in fact, available;

(5) any written or oral inquiry or record concerning the lawful source of income of a person;

(6) inducing or attempting to induce, for profit, any person to sell or rent any dwelling by representation regarding the entry or prospective entry into the neighborhood of a person with a particular lawful source of income; and

(7) discrimination against any person, in making a residential real estate transaction available, or in the terms or condition of such a transaction because of a person's lawful source of income.

VOTE FOR or AGAINST the proposed ordinance amending Title 11 of the Lincoln Municipal code.




