RECOVERY ROOM 7 PARTICIPANT AGREEMENT

This Client Agreement is entered into by and between Teshuvah Road Ministries, Inc. DBA Recovery Room 7 and _____ ("Client").

1. PROGRAM OVERVIEW:

This discipleship-based recovery program provides faith-based Restoration Coaching through balanced biblical discipleship, rooted in surrender to Jesus Christ and obedience to His Word. Coaching is a forward-focused, client-driven partnership aimed at supporting full recovery and lasting personal transformation. It is not a substitute for professional mental health treatment, medical care, or legal services, and nothing in this agreement shall be construed as therapy, diagnosis, or legal advice.

Client and Life Coach Relationship: Both parties recognize that the Client-Life Coach relationship is a partnership or alliance, not a legal relationship. The Client understands that the services provided by the Life Coach can cover various aspects of their personal life, such as life, relationships, career, education, recreation, fitness, and finances. It's ultimately up to the Client to decide how they want to apply the Life Coach's services and techniques to their life.

This discipleship coaching program is offered by Teshuvah Road Ministries Inc, DBA Recovery Room 7, for a donation of **any** amount the client is able to comfortably afford. We serve individuals seeking healing and transformation through Jesus Christ and true salvation. The role of the coach is to walk alongside the client, offer support, prayer, guidance, biblical discipleship, biblical wisdom, and accountability. I (client) understand that my personal growth and recovery are ultimately dependent upon my true salvation through Jesus Christ, my willingness to apply all of what I learn, take personal responsibility, and allow the Holy Spirit to lead my transformation. I understand that coaching outcomes cannot be guaranteed and vary based on the depth of my personal engagement and the definition of coaching (as specified below in section 2). We are not in agreement with any disease theories concerning addiction and will never call anyone a demeaning term such as an 'addict' or force anyone to confess they are or

were an 'addict'. The word 'addict' is never used in this ministry. When Jesus heals, HE heals for a lifetime. We firmly stand on that fact, completely based on Scripture.

2. DEFINITION OF OUR CHRISTIAN LIFE COACHING:

Our specialized Christian Life Coaching is a Christ-centered, non-clinical discipleship and support process that helps you learn how to break free from addiction, destructive habits, and life-controlling struggles by aligning your life with biblical truth. It is not therapy, counseling, or a substitute for professional medical or psychological care. This coaching process is designed to help you grow spiritually, take ownership of your life, and move toward lasting transformation through a submitted relationship with Jesus Christ and the power of the Holy Spirit. Every decision you make is entirely your own. Your coach will not give advice, but will instead support, encourage, and equip you to discern and follow your own next steps with clarity and confidence

I, the Client, acknowledge that this coaching process is biblically based, incorporates personal accountability, and is founded upon my relationship with Jesus Christ as the basis for pursuing lasting recovery. My participation does not guarantee my outcome, and the results of this process is entirely dependent upon my personal faith, my willingness to engage, my consistent application of biblical principles, and my own responsibility to make and follow through on decisions regarding my choices and growth. - Notify my Coach by text, email, or through Telegram at least 24 hours in advance if I need to reschedule.
- Limit cancellations and understand that two missed or unexcused sessions may result in immediate discharge from the program without my donation being refunded to me.
- Fully complete all assignments and reflective exercises, delivered to me by email, within the specified time.
- Check in a minimum of once a day with my progress on the Telegram app.
- Be honest, open, transparent, and spiritually receptive throughout the process.
- Participate in prayer, Scripture-based growth, and accountability as part of the coaching framework.

- I, the undersigned, voluntarily elect to participate in the coaching services offered by Teshuvah Road Ministries, Inc., through its online Christian virtual recovery program known as Recovery Room 7, and hereby request to receive those services under the terms of this agreement.

- I acknowledge and agree that I am solely responsible for my personal progress, decisions, and actions during and after my participation in this Christian Virtual Recovery Coaching Program. I understand that any outcomes depend on my willingness to engage, apply biblical principles, and take ownership of my choices.

- **Client Responsibility and Indemnification**

I understand that Teshuvah Road Ministries, Inc. DBA Recovery Room 7 provides Christ-centered coaching, discipleship, education, encouragement, and support, and does not provide medical care, mental health treatment, detox services, legal advice, or emergency services.

I agree that I remain personally responsible for my own decisions, actions, health, safety, recovery choices, and spiritual walk. I further agree not to hold Teshuvah Road Ministries, Inc. DBA Recovery Room 7, its coaches, board members, volunteers, agents, or affiliated parties responsible for claims, losses, damages, costs, or expenses arising from my participation in the program or from actions I choose to take based on information received through the program, except where prohibited by law or in cases of willful misconduct or gross negligence.

- **Coaching Services Disclaimer:** The coaching, teaching, and spiritual guidance provided through Recovery Room 7 do not constitute medical, psychological, therapeutic, psychiatric, legal, financial, or other professional advice. Coaches offer faith-based encouragement, personal reflection, and spiritual growth support only. I agree that I am solely responsible for seeking qualified licensed professionals regarding my health, mental well-being, legal matters, finances, or any other area requiring professional expertise.

- Release of Claims: I (the client) hereby release and agree not to pursue any legal action, complaint, or claim against Teshuvah Road Ministries, Inc., or Recovery Room 7, its coaches, board directors, employees, volunteers, representatives, or affiliated parties for any claims, damages, or losses arising out of or related to my participation in this Christian Recovery Coaching Program, to the fullest extent permitted by law.

- I represent and warrant that I am at least 18 years of age, of sound mind, and capable of entering into this agreement.

- This agreement becomes effective immediately upon my signature and shall remain in full force and effect for the duration of my participation in Recovery Room 7, unless otherwise terminated by mutual agreement or as set forth in the program's terms.

FEES

In such cases, no refund or prorated refund of donations will be issued, and the client agrees not to hold the ministry, its coaches, its board directors, or affiliated parties liable for any resulting consequences.
