

**TAX LEVY ORDINANCE
BOURBONNAIS TOWNSHIP**

ORDINANCE #12-25-01

An ordinance levying taxes for all town purposes for Bourbonnais Township,
Kankakee County, Illinois, for the year 2025, collectable in 2026.

BE IT ORDAINED by the Board of Trustees of Bourbonnais Township,
Kankakee County as follows:

SECTION 1: That the sum of SEVEN HUNDRED THOUSAND NINE
HUNDRED EIGHTY Dollars (700,980) are hereby levied upon all property
subject to taxation within the Township as that property is assessed and equalized in
order to meet and defray all necessary expenses and liabilities of the Township as required
by statute or voted by the people in accordance with the law, for such purposes as:

ILLINOIS MUNICIPAL RETIREMENT FUND

SOCIAL SECURITY FUND

GENERAL ASSISTANCE FUND

for the year 2025, collectable in 2026.
