## Young rural advisors in Europe

The beginning of a young advisor's career is difficult. It is a beautiful but also demanding job to support entrepreneurs such as farmers to not only be economically successful but to also integrate environmental and welfare issues. While universities can provide theoretical knowledge, this is still not enough for young advisors to thrive in this attractive but challenging profession at the beginning of their careers. Many young advisors leave their positions within the first year. The results are the following: high costs, high turnover rates, and waste of resources. Another development is, that advisory services are experiencing a crisis where the over-aging of advisors has exposed them to the risk of losing their know-how, which is mainly intangible knowledge, within the human beings themselves, based on long years of experience. Often there is no institutionalized framework or routine knowledge management to hand over these competencies in a structured way to the next generation of advisors. The Young EUFRAS training program will bridge this hand-over gap that exists within the advisory services by pairing experienced advisors with young advisors.

Young advisors are crucial in supporting the sustainable food producers of today and tomorrow. Extension and advisory services are important to keep current farmers and especially young future farmers interested in producing food and contributing to food security, young advisors with fresh knowledge are needed for this. However, rural advisory services all over Europe experience comparable challenges in recruiting, qualifying, and offering long-term attractive working conditions for young advisors. The development costs for individual trainee programs for a limited number of young advisors are too high. The international European Young EUFRAS advisors training program allows especially smaller rural advisory services from all over Europe to become a more attractive working place for young specialists. This will contribute to achieve their tasks in strengthening rural areas. Particularly advisory services from smaller and new EU member states will benefit from the program, as funds for human resource development is simply often not available.

The focus of the Young EUFRAS training program is on the qualification of its 20 participants. At the same time, it offers an interesting networking opportunity for young rural advisors from all over Europe. The idea of networking in this case is that young advisors learn from each other and support each other. EUFRAS wants to accelerate the establishment of YEUFRAS as a youth section within its network and aims at a long-term connection between participants of this program. When applying to this program you are going to be asked if a commitment for YEUFRAS in the future is an option for you. This is going to be a selection criterion for participation.

## The CECRA Certificate

The CECRA Certificate is an integral part of the Young EUFRAS mentoring and training program 2026/27. The full CECRA Certificate is rewarded to the participants of this program after completion of the CECRA requirements.

A rural advisor applying for the basic CECRA certificate at his/her local CECRA certification body must fulfill the following requirements\*<sup>1</sup>:

### CECRA Basic

- Attendance of minimum 5 CECRA modules out of a total of 20 modules, thereof
  - 2 compulsory modules
    - M01 My Profile as a Consultant*
    - M02 Communication and Relationship Building in Advisory Work*
  - 3 (or more) elective modules

### Full CECRA Certificate

To apply to the full CECRA Certificate, in addition to taking the 5 CECRA modules, as outlined above, the participant must complete the following requirements:

- Attendance of an event in another country. The attendance to the annual IALB-EUFRAS-SEASN conference fulfills this requirement.
- Study visit to an advisory service abroad with moderated knowledge exchange. The visit must last 2.5 days.
- Submission of a practice-oriented thesis (documentation and self-reflection based on a practical example) -> Capstone Project within this program.
- The advisors must have two years' relevant professional experience in the advisory sector.

Module Confirmations serve as proof of attendance. Only accredited CECRA Module providers have the exclusive right to issue Module Confirmations.

## History and background of YEUFRAS and this Mentoring and Training Program

Since the foundation of EUFRAS in 2014, in conjunction with the IALB-owned CECRA system (Certificate for European Consultants in Rural Areas), EUFRAS developed advisor methods trainings. Since 2018, EUFRAS offers annual workshops for young advisors within the scope of its annual joint conferences. In 2020, the first CECRA workshop was held for young agricultural advisors from ten countries. Given the interest and need formulated by its member organizations, the EUFRAS board decided to further invest in the development of young rural advisors. In the years 2022-23, EUFRAS, together with the "State Academy for Nutrition, Agriculture and Forestry (FüAk)", the global organization "Young Professionals for Agricultural Development (YPARD)", the Slovenian Chambers of Agriculture and Forestry Services (CAFS) and the Irish rural advisory service (TEAGASC) successfully realized the first Erasmus+ funded training and mentoring program for 20 young advisors across Europe. In this second edition of the Young EUFRAS program, while the program is open for participants from all over Europe, the focus is on South-East Europe, as the rural advisor organizations from EU-countries and accessing candidate countries, including Ukraine, formulated the biggest need of a comprehensive young rural advisors training program. The composition of the partners – SEASN and IPN joined the project – and the selection of the places for the face-to-face events reflects this focus.

### Methodological Approach: Training Concept, Mentoring Concept and Capstone-Project, Networking

The program combines classical trainings with a mentoring approach and networking elements. The program offers space for 20 Young Advisors (participants). The program's working language is English.

#### *Training Concept*

Training is a core element of this project. In the training setting, experiences can be exchanged, and advisor situations practiced in a secure and safe environment. The proper role as advisor will be reflected. A practical exercise, where advice is given under supervision to entrepreneurs is included in the program.

5 interactive 2-day Trainings are going to be realized face-to-face and online. The program concentrates on cross-cutting methodological competences which are relevant for all disciplines (crop advisor, livestock and animal welfare advisor, economist, agroecologist, horticulturist, etc.). The CECRA framework guarantees interactive trainings of highest standards.

The curriculum is partly developed in cooperation with the participants based on a need analysis realized in the beginning of the program. The main pillars of the training units are set (see schedule below). There is flexibility in the second half of the program concerning the training contents.

Expected result: Participants are confident in advisor methods and master key expertise needed for supporting farmers and other clients in rural areas in change and innovation.

### *Mentoring and Capstone project*

Participants will realize a mentored advisory visit on a farm with intense reflection of their advisor performance. Here, they apply and test in practice what they learned in the trainings. They are supervised by experienced mentors and get qualified feedback in well-organized reflection rounds. The mentored farm visits are integrated in the two face-to-face training weeks.

The participants are visiting the advisory service Teagasc in Ireland for 3 days in April 2027 (see timetable). This trip will include a visit to the local advisory service and farm visits under the supervision of the Teagasc mentors. Participants benefit from the practice experience, and subsequently their advisory services and clients.

Participants are expected to produce a written elaboration of an advisor's capstone project, where an advisory process is reflected systematically, is part of the program.

For the visit of the advisory service abroad and the capstone project, CECRA guidelines and checklists are used for orientation.

### *Networking*

The project's goal to establish a sustainable network for young rural advisors is fostered by network events. The 20 participants of the program are invited to organize a workshop on Strategy development for YEUFRAS. This Dissemination and Strategy workshop is realized in Austria, June 25, 2027, as an activity during the annual European rural advisors' conference 2027. Participants will be asked to contribute to the project website on EUFRAS and SEASN homepages and the social media coverage.

Online-Communication will be organized by WhatsApp, establishing a team chat room, Zoom and the EPAL platform, and a team-room for data exchange.

### **Target group**

Target group of this program are **European young rural advisors, younger than 35** years old, at the beginning of their career. This is no strict age limit. Also, older persons can apply. To benefit from the program, good command of the English language is a precondition.

### **Ukrainian Young EUFRAS Group**

Parallely to the Young EUFRAS Program 2026-27 in English language in Slovenia/Serbia/Ireland, it is planned to train a group of 11 Young Rural Advisors in Ukrainian language in Ukraine and Slovenia. This group is also led to the full CECRA Certificate until June 2027.

## Program Overview, Training Dates, Networking events

There are two in-person trainings composed of five days each, and one digital course along with networking events that will take place over the period of 16 months.

- In the Kick-Off online meeting in July 2026, participants are familiarized with the program
- For the first training week in September 2026 in Slovenia, participants are staying 5 days and start with CECRA Modules 1 and 2. One day will be dedicated to mentored farm advisor visits.
- In November 2026, the 20 participants meet in Serbia, to realize 2 CECRA trainings and further mentored advisor farm visits (5 days).
- The CECRA visit of an advisory service abroad will happen in April 2027 (3 days)
- Participants meet for the YEUFRAS strategy workshop in Austria, June 25<sup>th</sup>, 2027, and visit the Rural Advisors IALB-EUFRAS-SEASN conference 24-27, 2026. (4 days)

➔ Thus, in total, 17 travel days are included on 4 occasions.

- One further 2-day CECRA training, training on economics, gender and mental health, networking meetings and further organizational meetings are realized online.
- A few days are needed to write the capstone-project. In total, participants are involved in active program elements for 20 days, plus their individual work, preparation and reflection time.
- The CECRA certificates are going to be awarded at the Rural Advisors IALB-EUFRAS-SEASN conference in Tirol (Austria) in June 2027.

### Participant fee

There is no possibility for refunding the participant fee, as the program starts in September 2026, shortly after the registration deadline.
