- c) The A30, Liveable neighbourhoods, National Cycling route 4; All will need monitoring and we will need to keep a high profile with the relevant Authorities to ensure that these items stay or are brought to the top of the pile in the Surrey CC Highways 'to do' list. Alan will pursue
- d) Bond Street hedging and trees; Debi to discuss planting volunteers with EGVRA nearer the time (and when we have received confirmation that it will actually happen)
- e) Forest Estate Garden Project. Still on back burner, but the Labour Councillors in a brief exchange (Mike/ Abby) appear not to have dismissed it but to have considered it too difficult financially for now.
- f) Central Area remodelling and signage. Mike did a presentation to RBC a copy of which has been circulated. Following a meeting with Marissa Heath and Trevor Gates, Mike will go out to tender for the work to establish a firmer estimate and because no funds will be released without quotations.
