



SELLER AGREEMENT

T&S Water Co. Ltd

This Agreement is between:

T&S Water Co. Ltd (“The Company”)

Registered in England & Wales, Company No. 16516934

and

(“The Seller”)

1. Purpose of Agreement

This Agreement outlines the terms and conditions under which the Seller may introduce potential customers (“Leads”) to T&S Water Co. Ltd for the purpose of offering finance options for Enagic.

2. Role of the Seller

- The Seller acts solely as a referral partner.
- The Seller is not authorised to provide financial advice, discuss finance rates, or complete finance applications on behalf of customers.
- The Seller’s sole responsibility is to introduce interested customers to T&S Water Co. Ltd using the approved referral link, form, or submission process.

3. Role of T&S Water Co. Ltd

- T&S Water Co. Ltd will process all customer leads through its approved finance partner(s) (e.g. Ideal4Finance Ltd).
- The Company will manage all communication with the finance provider and the customer strictly for the purposes of completing the finance application.
- The Company is responsible for ensuring all data and applications are processed in accordance with FCA and Data Protection regulations.

4. Referral Link Policy

- Sellers will receive a unique referral link or lead submission form for use in connection with T&S Water Co. Ltd’s finance introduction service.
- This link is for the Seller’s personal and authorised business use only and must not be:
- Shared publicly on websites, social media, paid ads, or third-party platforms without written approval from T&S Water Co. Ltd.
- Forwarded, transferred, sold, or assigned to any other individual or entity.
- Embedded in automated funnels or redirected through other domains.
- Any unauthorised sharing or misuse of the referral link will be treated as a material breach of this Agreement and may result in immediate termination of access, with no refunds.
- T&S Water Co. Ltd reserves the right to track and audit all referral activity to ensure compliance.



5. Ownership of Leads & Non-Solicitation

- All leads provided by the Seller remain the sole property of the Seller.
- T&S Water Co. Ltd will not contact, market to, or solicit any of the Seller's leads outside the scope of processing the finance application.
- T&S Water Co. Ltd will not re-market, re-contact, or attempt to poach any leads or customers submitted by the Seller.
- The Seller's customer relationships remain fully protected at all times.
- Any breach of this clause constitutes a material breach of this Agreement and may result in immediate termination.

6. Payment Terms

- The Seller acknowledges that this referral arrangement is non-commissioned and unpaid.
- The Seller will not receive any financial compensation, commission, or referral fee from T&S Water Co. Ltd for introducing customers.
- All financial arrangements between T&S Water Co. Ltd and any third-party finance providers remain strictly confidential and are not part of this Agreement.
- The Seller participates solely to provide an additional finance option for their customers.

7. Customer Payment Responsibilities

- Customers remain responsible for all repayments and obligations under their finance agreements.
- The Seller must not interfere with, alter, or attempt to negotiate customer finance terms.

8. Data Protection & Confidentiality

- Both parties agree to comply with the UK General Data Protection Regulation (GDPR) and Data Protection Act 2018.
- T&S Water Co. Ltd shall ensure all personal data is securely handled and used solely for the purpose of processing the finance application.
- The Seller agrees not to share or disclose any confidential information about T&S Water Co. Ltd, its processes, finance partners, or customers.

9. Use of Marketing Materials

- The Seller may use approved marketing materials, logos, and documents provided by T&S Water Co. Ltd.
- All promotional materials must be pre-approved to ensure compliance with FCA guidelines.
- Sellers must not create or distribute their own finance-related marketing without written consent.



10. Limitation of Liability

- T&S Water Co. Ltd shall not be held liable for any loss, claim, or damages resulting from the Seller's actions or representations.
- The Seller is responsible for ensuring their own customers understand that finance is subject to status, approval, and availability.

11. Termination

This Agreement may be terminated:

- By either party with written notice; or
- Immediately, if either party breaches the confidentiality, data protection, or compliance clauses.

Upon termination, the Seller must immediately cease referring customers and remove any use of T&S Water Co. Ltd branding or materials.

12. Entire Agreement

This document constitutes the full understanding between the parties and supersedes any prior discussions, verbal or written, relating to the subject matter herein.

13. Governing Law

This Agreement shall be governed by and construed in accordance with the laws of England and Wales.
