1. Introduction

These Terms & Conditions govern your participation as a Seller with T&S Water Co. Ltd. By signing the Seller Agreement and using our finance introducer system, you agree to comply fully with these terms.

2. Role & Status

- You act as an independent seller, not as an employee or agent of T&S Water Co. Ltd.
- We act solely as an Introducer Appointed Representative of an FCA-authorised principal.
- You may only refer customers using our approved process and materials.

3. Compliance & Conduct

- You must not give financial advice, negotiate terms, or assist in completing finance applications.
- You must use only the approved finance referral link and lead submission form.
- You must not mislead customers or make claims outside of compliance guidelines.
- You agree that T&S Water Co. Ltd will never contact or poach your leads.

4. Payments & Fees

- A one-off joining fee of £500 (or 3 monthly payments of £200) is required to activate access.
- This fee is non-refundable under any circumstances.
- No commissions or payments are made to sellers for referrals.
- All financial arrangements between T&S Water Co. Ltd and third-party finance providers remain confidential.

5. Intellectual Property

All marketing materials, logos, training, and tools remain the property of T&S Water Co. Ltd. Sellers may not reproduce or share them without written consent.

6. Referral Link Policy

- Sellers will receive a unique referral link or lead submission form for use in connection with T&S Water Co. Ltd's finance introduction service.
- This link is for the Seller's personal and authorised business use only and must not be:
- Shared publicly on websites, social media, paid ads, or third-party platforms without written approval from T&S Water Co. Ltd.
- Forwarded, transferred, sold, or assigned to any other individual or entity.
- Embedded in automated funnels or redirected through other domains.
- Any unauthorised sharing or misuse of the referral link will be treated as a material breach of this Agreement and may result in immediate termination of access, with no refunds.
- T&S Water Co. Ltd reserves the right to track and audit all referral activity to ensure compliance.

- You must submit leads only through the official Seller Lead Form.
- All personal data must be handled in accordance with the UK GDPR and Data Protection Act 2018.

8. Termination

- Upon termination, you must immediately stop using all tools and materials.

9. Legal

- This agreement is governed by the laws of England & Wales.
- Any disputes shall first be referred to mediation before legal proceedings.
- These terms may be updated to remain compliant with FCA and legal obligations.
