The overall 2026 proposed budget increased by \$252,914 (13.9%) from the 2025 Budget, this increase is attributed to the addition of \$125,000 for reserve for future capital, \$40,500 increase in agreement with fire department and \$70,000 increase for various non-bondable equipment needs. The increase in reserve for future capital is to purchase a new fire apparatus in 2027/2028.

Revenues - A. Unrestricted fund balance increased by 264%/230k. This was needed to balance the budget and keep the tax increase at 2.5%. The District has built a healthy fund balance due to excellent fiscal controls. They are using this fund balance to purchase a fire truck so they do not have finance it which saves financing costs. B. Restricted fund balance decreased by 100%/14,700. This is due to prior budget item HVAC upgrades. Appropriations - A. Fringe benefits under cost of operations increased by 23% due to increase in salaries as well as increase in health insurance costs. B. Fire protection services increased 33% or 40,500 due to new agreement amount. C. Training and education decreased by 33% or 2,000 due less need.. D. Other assets increased for equipment needs as well necessary upgrades for radios and a generator. E. Fringe benefits decreased due to allocation with other lines. F. Capital appropriations increase by \$125,000 to save for future fire apparatus purchase. H. Debt service interest decreased by 34% due to amortization schedule.
