The regular monthly meeting of the Board of Fire Commissioners of Fire District No. 1 of Middle Township was held on this date at the FireHouse, 112 Hand Ave., Cape May Court House, New Jersey. A Special Meeting was held at 7:00pm to adopt the 2023 Budget. There was no public input at this time. **Resolution 2023-01:** Authorization to adopt the 2023 Fire District #1 Budget was passed by all Commissioners in attendance.

Commissioner Michael McNulty opened the meeting at 8:00 P.M., inviting those in attendance to join him in saluting the flag.

Commissioner Trombetta presented the following treasurer's report: Operating Fund: \$899,164.18. On a motion of Commissioner Hand, seconded by Commissioner Arenberg, the treasurer's report was accepted by a unanimous voice vote.

The monthly bills were presented. The bills totaled \$52,047.09 Dec. 16-31, \$42,460.03 Jan. 1-9 \$9,587.06. Commissioner Arenberg moved the bills to be paid. Commissioner Hand provided a second to the motion, which was carried by a unanimous voice vote.

The monthly report from the Bureau of Fire Prevention for Districts #1, #3 and #4 was received and made a part of these minutes. Also received was the Certified List of qualified volunteers for 2019 LOSAP Award Program.
