

**FIRE DISTRICT NO. 1 OF MIDDLE TOWNSHIP

March 9th, 2026

The regular monthly meeting of the Board of Fire Commissioners of Fire District No. 1 of Middle Township was held on this date at the FireHouse, 112 Hand Ave., Cape May Court House, New Jersey. The following members of the Commission were present, Craig Mericle, Keith Arenberg, Lewis Hand, Phil Woodrow and Michael Clark. This meeting is a public meeting held in compliance with P.L. 1975 (commonly referred to as the "Sunshine Law") and has been appropriately advertised. Exits have been indicated in compliance with the New Jersey State Fire Code.
