CA CANADA STUDY VISA (STUDENT PERMIT) – DOCUMENTS CHECKLIST

PHASE 1: UNIVERSITY/COLLEGE ADMISSION

- 1. Valid Passport (Must be valid for at least 6 months beyond your planned stay)
- 2. National ID (CNIC/NICOP) (Front and back)
- 3. Educational Documents
 - Matric & Intermediate certificates (IBCC attested)
 - Bachelor's/Master's degrees (HEC + MOFA attested)
 - Transcripts (front and back)
 - Apostille (if requested)
- 4. English Language Proficiency Test
 - IELTS Academic / TOEFL (CLB 6.0 minimum for SDS) CELPIP accepted in some cases
- 5. **Updated Resume / CV** (Canadian format preferred)
- 6. **Statement of Purpose (SOP)**(Our team provides samples/quidance)
- 7. Recommendation Letters (Two academic/professional with referee contact info)
- 8. **Experience Letters** (Matching details from your resume)
- 9. **Passport-Sized Photos** (35mm x 45mm, white background)
- 10. **Application Portal Submission** With application fee payment (typically CAD \$100-\$150)
- 11. Letter of Acceptance (LOA) From a Designated Learning Institution (DLI)

PHASE 2: VISA DOCUMENTS – STUDY PERMIT APPLICATION (IRCC)

Required for both SDS (Student Direct Stream) and Non-SDS streams:

- 1. Letter of Acceptance (LOA) (From DLI with DLI number)
- 2. Valid Passport
- 3. **Digital Photo** (Meets IRCC format and size)
- 4. Family Information Form (IMM 5645) (Completed and signed)
- 5. Visa Application Form (IMM 1294) (Completed online)
- 6. Visa Fee Payment Receipt (CAD \$150 (Study Permit) + CAD \$85 (Biometrics))
- 7. Biometrics Appointment Confirmation
- 8. IELTS (Min. 6.0 in each band for SDS)
- 9. Educational Documents (Degrees, transcripts, certificates)
- 10. Statement of Purpose (SOP) (Clear study plan with valid reasons for choosing Canada)

PHASE 3: FINANCIAL DOCUMENTS

For SDS (Student Direct Stream):

- 1. Guaranteed Investment Certificate (GIC) CAD \$10,000 from a Canadian bank
- Tuition Fee Payment Receipt (Proof of payment for 1 year's tuition)

For Non-SDS (Regular Stream):

- 1. Bank Statement (Last 4–6 months)
 - Student or sponsor's account
 - Sufficient to cover tuition + 1 year living costs
- 2. Bank Account Maintenance Letter
- 3. Affidavit of Support (if sponsored)
 - On Rs.100 stamp paper, notarized
- 4. Relationship Proof with Sponsor
 - FRC or Birth Certificate
- 5. Source of Funds Evidence
 - Salary slips, tax returns, business documents, etc.

SUPPORTING DOCUMENTS

- Police Clearance Certificate (PCC)
 - Not mandatory but recommended
- Medical Exam (IME)
 - Panel physician exam if applying through SDS
- Property/Asset Documents (optional)
 - To strengthen home country ties

ADDITIONAL NOTES

- All documents must be in English or French, or officially translated
- SOP and financial strength are key to visa success
- Ensure document consistency and proper file naming for online upload
- Avoid incomplete applications—delays or refusals are common
