# <u>CA Canada Work Permit – Document Checklist</u>

### A. Personal Documents (Applicant)

- 1. Valid Passport (Clear copies of all pages with stamps and visas)
- 2. Recent Passport-Size Photos (As per IRCC specifications)
- 3. National Identity Card / CNIC
- 4. Birth Certificate (translated if not in English or French)
- 5. Marriage Certificate (if applicable)
- 6. Children's Birth Certificates (if applying with dependents)
- 7. Police Clearance Certificate (from each country lived in >6 months over last 10 years)
- 8. Medical Examination Report (from IRCC-approved panel physician) Required before visa stamping for certain jobs/countries

### **B. Educational & Professional Documents**

- 1. Educational Certificates (Degree, Diploma, Transcripts)
- 2. Experience Letters (for all relevant jobs mentioned in the resume)
- 3. Updated Resume/CV (in Canadian format)
- 4. Trade/Skill Certifications (if applicable e.g., Red Seal, ITA, etc.)
- 5. Professional Licenses or Memberships (if required for the occupation)

#### **C.** Language Proficiency

- 1. IELTS General Training Test Result (optional for LMIA-based visas but preferred)
  - Not mandatory for every work permit but beneficial for processing, especially if applying for permanent residence later.

# **D. Employment-Related Documents**

(Usually provided by the Canadian employer)

- 1. Job Offer Letter (Official signed letter with job title, duties, salary, duration)
- 2. Labour Market Impact Assessment (LMIA) Positive decision letter (if applicable)
- 3. LMIA Number Needed for work permit application
- 4. Employment Contract
- 5. Employer's Business Documents (Optional but sometimes requested registration, tax filings)







# E. Financial & Travel Documents

- 1. Bank Statement (past 3–6 months showing financial stability)
- 2. Bank Maintenance Certificate
- 3. Travel History (previous visas, stamps, refusals if any)
- 4. Flight Itinerary (tentative only not mandatory but helpful)
- 5. Accommodation/Temporary Housing Plan (optional)

#### F. Supporting Documents (if accompanied by dependents)

- 1. Marriage Certificate
- 2. Children's Birth Certificates
- School Admission Letters (if children are school-aged)
- 4. Proof of Funds for Dependents

## Additional Documents (If Applicable)

- Refusal Letters (for any previous Canada visa denials)
- Intent to Return statement (to show ties to home country especially for temporary workers)
- Cover Letter or Statement of Purpose (helpful in explaining employment plan and background)

#### Notes:

- All documents not in English or French must be translated by a certified translator.
- Some visa offices may request additional forms (IMM 1295, IMM 5645, etc.).
- Biometrics are mandatory for most applicants.
- Medical and police clearance are typically required before final decision.
- Processing time varies by country and occupation (typically 8–20 weeks).
