# **GERMANY STUDENT VISA – DOCUMENTS CHECKLIST**

#### A. UNIVERSITY ADMISSION DOCUMENTS

- 1. Valid Passport (Copies of the first and last page Include travel history)
- 2. National ID (CNIC) (Front and back)
- 3. Educational Documents
  - Degrees, diplomas, and transcripts (front & back)
  - Attested by:
    - ◆ IBCC (Matric/Intermediate)
    - HEC (Bachelor's/Master's)
    - ♦ MOFA
    - ◆ APS Certificate required for Pakistani students (see note below)
- 4. APS Certificate
  - o Mandatory for Pakistani applicants
  - o Applied through APS Germany Pakistan portal
  - Must be submitted before visa application
- 5. Passport-Sized Photographs (Biometric (35mm x 45mm), white background, recent)
- 6. Curriculum Vitae (CV) (In Europass format)
- 7. **Experience Letters** (if any work history is shown in the CV)
- 8. **Motivation Letter / Statement of Purpose** (Sample will be provided)
- 9. Language Proficiency Certificate
  - **IELTS/TOEFL** (for English-taught programs)
  - TestDaF / DSH / Goethe Zertifikat B2 or C1 (for German-taught programs)
- 10. Preliminary Medical Insurance (for first 90 days)
  - Valid in Schengen zone (e.g., EDUCARE24 or Mawista)
- 11. Thesis / Final Year Project Summary (For postgraduate students)
- 12. **Interview Preparation** (Support provided by our team)

#### **VISA DOCUMENTS**

- 1. **Proof of Financial Means** (Any ONE of the following)
  - Blocked Account (€11,904 for one year €934/month) in a German bank (e.g., Expatrio, Fintiba, Deutsche Bank)
  - OR Scholarship Letter confirming sufficient funds

#### 2. Blocked Account Confirmation Letter

From your provider (PDF confirmation)

#### 3. **Proof of Accommodation**

Hostel confirmation, rental contract, or invitation letter

## 4. Health Insurance (for full stay)

o Public health insurance (TK, AOK, etc.) OR Private health insurance (Mawista/EDUCARE24 until university enrollment)

## 5. Travel Itinerary / Flight Booking

Tentative reservation only

## 6. No Objection Certificate (NOC)

From employer or current educational institution (if applicable)

# 7. **Sponsor's Documents** (if applicable)

- CNIC
- Affidavit of support (notarized)
- Source of funds: salary slips, tax returns, business documents

#### 11. Visa Fee Payment Receipt

• €75 in local currency (confirm at embassy)

#### 12. APS Certificate (Original + 2 Copies)

• Again, this is mandatory for all Pakistani applicants

# NOTES & REMINDERS

- All documents must be in **German or English**. Provide **certified translations** where applicable.
- Always carry 2–3 sets of photocopies of all documents to your visa appointment.
- Submit documents at least 8–10 weeks before course start date.
- The APS process may take 4–8 weeks, so plan ahead.
