# **GB UK Skilled Worker Visa – Checklist & Document Guide**

### A. Personal Identification Documents

- 1. Valid Passport (must have at least one blank page)
- 2. Old Passports (with travel history, if applicable)
- 3. Passport-Size Photograph (UKVI-compliant, if required)
- 4. **CNIC/NICOP** (for Pakistani nationals or relevant ID for others)

### B. Proof of English Language Proficiency

One of the following is required:

- IELTS UKVI (Academic/General) Minimum B1 level
- **Degree taught in English** (with Ecctis/NARIC certificate)
- Exemption (citizen of majority English-speaking country)

#### **C.Financial Requirement**

If your employer is NOT certifying maintenance, provide:

- Personal Bank Statement showing at least £1,270
  - Must be held for 28 consecutive days
  - Statement must be recent (within 31 days before application)

If employer does certify maintenance on CoS, this requirement is waived.

# D. Tuberculosis (TB) Test Certificate

- Mandatory if applying from TB-listed countries (e.g., Pakistan, India, Nigeria)
- Issued by a UKVI-approved panel clinic
- Valid for 6 months

# **E. Additional Supporting Documents**

- 1. Police Clearance Certificate (may be required depending on job or employer)
- 2. **Academic Qualification Documents** (if required for the role)
- 3. Experience Letters/References (if relevant or requested)
- 4. Updated CV / Resume
- 5. **Professional License or Registration** (if job is regulated in the UK e.g., nurse, teacher, doctor)

#### F. Visa Application Steps & Fees

- 1. Complete Online Application via gov.uk
- 2. Pay Application Fee:
  - £719 (up to 3 years)
  - £1,420 (over 3 years)

- Shortage occupation discount: £551 / £1,084
- 3. Pay Immigration Health Surcharge (IHS):
  - £ 1,035 per year of visa validity
- 4. Book Biometric Appointment via VFS Global (Gerry's)

### **G.** Post-Visa Issuance Documents

- Visa Vignette (in passport)
- Decision Letter from UKVI
- Biometric Residence Permit (BRP) to be collected within 10 days of arrival in the UK

#### **Important Notes:**

- Job must be genuine and meet salary & skill threshold
- Ensure employer is on the official list of licensed sponsors
- Processing time: 3 weeks (standard) or 5 working days (priority)
- Dependents can apply together (spouse/children under 18)
