Idikajang was established under the name PT Darma Utama Sapta based on Deed of Establishment No. 12, dated March 3, 1978, by Notary Raden Soerojo Wongsowidjojo, S.H., domiciled in the Administrative City of Jakarta. On June 16, 1978, the Company amended its Articles of Association and changed its name to PT Idi Kajang based on Amendment Deed No. 34, dated June 16, 1978, by the same Notary, ratified by the Minister of Justice Decree No. Y.A.5/216/12, dated July 31, 1978.

The Company's Articles of Association have undergone several amendments. In 2009, the Company was officially renamed **PT Idi Kajang Consultants** in accordance with Law No. 40 of 2007 on Limited Liability Companies, based on Deed No. 34, dated March 12, 2009, by Notary Siswadi, S.H., with ratification from the Minister of Law and Human Rights on March 15, 2009 (No. AHU-12796.AH.01.02, 2009). The Articles of Association were last amended in 2022 through Notarial Deed No. 05, dated March 30, 2022, by Kasmita Syafni, S.H., Notary domiciled in South Jakarta Administrative City, duly recorded with the Legal Entity Administration System of the Ministry of Law and Human Rights (No. AHU-0023887.AH.01.02, April 4, 2022).

State-Owned Enterprises (BUMN) play a vital and strategic role in utilizing and managing state-owned assets for the purpose of healthy and sustainable national development. In accordance with guidelines on asset optimization, BUMN are encouraged to strategically optimize the assets under their management. Under Law No. 19 of 2003 on State-Owned Enterprises, BUMN are entities whose capital is wholly or substantially owned by the state through direct equity participation derived from separated state assets. Based on this law, BUMN bears a dual responsibility: serving as an agent of development while also developing its core business to sustain the company's operations.

In the context of maintaining business sustainability and addressing increasingly competitive global challenges, BUMN must enhance added value through maximizing the utilization of all assets in line with optimal service delivery. However, the reality is that many BUMN assets remain underutilized. PT Aneka Tambang (ANTAM), as a mining company with an industrial cycle spanning from exploration to post-mining phases, faces the challenge of post-mining asset management. Upon entering the post-mining phase, all production and operational activities cease.



The consequence of post-mining designation is that production support assets become non-productive or Non-Productive Assets (ANP). Meanwhile, ANTAM continues to bear maintenance costs and tax obligations on these ANP, potentially leading to inefficiencies. Therefore, ANTAM requires a planning instrument (masterplan) as the basis for future ANP management.

Addressing these challenges — both external (increasingly competitive global business landscape) and internal (non-productive fixed assets) — ANTAM requires a strategic, systematic, comprehensive, integrated, and sustainable planning instrument. This Non-Productive Asset Management Masterplan serves as a guide for policymakers and stakeholders in promoting comprehensive and sustainable ANP utilization and management.

This project involved sampling locations at several ANP sites owned by ANTAM based on completed asset mapping results:

1. Pasca Tambang Kijang, Bintan, Riau Islands
2. Pasca Tambang Pasir Besi Cilacap, Cilacap Regency, Central Java
3. Pasar Tambang Pulau Gebe, North Halmahera Regency, North Maluku
