Terms and Conditions

1. Eligibility

- a. Open to individuals aged 18 or over.
- b. Members must reside in Australia.

2. Membership

- a. Membership is limited to 100 members 'Associates'.

3. Subscription Fee

- a. An annual fee of \$500 per associate.
- b. Annual fee can comprise of up to \$250 in goods/services (only as agreed by NRC) and the remainder in cash.
- c. Payment must be made in full prior to the receipt of any benefits and to be eligible for the prize draw.
- d. Payments are non-refundable unless the draw is cancelled.

4. Subscription benefits

- a. Signage
 - i. size of up to 1500mm x 1000mm
 - ii. sign to be provided by and cost borne by the 100 Club associate
 - iii. location of signage to be determined by the NRC
 - iv. NRC reserves the right to refuse to erect any signage it deems inappropriate.
- b. Free entry tickets
 - i. 6 (six) free tickets per race day
 - ii. Can be transferred to any person (gifted)
 - iii. Cannot be transferred to another race day without prior approval of the NRC
- c. Marquee entry
 - i. Marquee will be available only at the May 2026 meeting (date TBC)
 - ii. All other benefits at the discretion of the NRC
- d. Priority invite
 - i. Existing 100 Club associates will be entitled to a preliminary offer to re-join the following year

5. Draw Details

- a. The prize draws will be held at a time to be determined by the NRC with major prize draw at May Race meeting.
- b. Draws will be conducted publicly or in the presence of at least two witnesses.
- c. Winners will be selected randomly.

6. Prizes

- a. The total prize fund will be 50% of all subscriptions received.
- b. Prize distribution is to be determined by the NRC.
- c. Winners will be contacted within 7 days and prizes remaining unclaimed within 21 days of the draw will be forfeited to the NRC.

7. Use of Funds

- a. The remaining balance will go towards supporting the NRC.

8. Termination or Cancellation

- a. The NRC reserves the right to cancel the draw or adjust terms at any time with reasonable notice.
- b. In the event of cancellation, all funds (minus administration costs) will be refunded.

9. Data Protection

- a. Member data will be handled in accordance with relevant privacy laws.
- b. Personal data will only be used for the benefit of the NRC and draw administration. It will not be shared with third parties.

10. Disputes

- a. Any disputes will be handled by the NRC, whose decision will be final.

11. Legal Compliance

- a. The 100 Club is a category 2 game under the *Charitable and Non-Profit Gaming Act 1999* and complies with local laws and regulations regarding lotteries and raffles.
