DEALER AGREEMENT:

- Each dealer is assigned an area with tables(s) and two (2) chairs unless other arrangements are confirmed.
- None of the tables can be moved.
- Tables must be covered to the floor and all packing boxes must be hidden from view.
- NO extra tables may be used in front, beside or behind the assigned tables(s).
- All aisles must be kept clear.
- Electrical outlets are provided for each dealer. All cords must be taped down.
- Set up must be completed by 9:30 AM (Check in and set up may begin after 3 PM until 11 PM on Saturday the 13th or after 6 AM on Sunday).
- The show closes at 4 PM. Take down must be completed by 5:30 PM.
