Always exhausted and tired. Can not breath fully. Constant joint paih. Sensitive to loud noise. Often get bright 'stars' and 'strings' in my field of vision. Have 'floaters' in my right eye. Constant headache of varied intensity and usually nauseous, (headache and nausia has gotten much worse since I traveled by air). Can not exercise other than walking. Constant sinus infection and yellowed mucus. Awoken throughout the night and trouble breathing. Continuing errtatic skin sores, scars and eruptions and mottling/texturing over my body, face and head, (since contracting scabies in 2021). Feel as if someone died and I hurt inside and behind eyes, feel sad most of the time and fight all day to keep it inside as I can not show any misery on the outside having to stand strong, (since day one of being wrongly imprisoned and growing worse with time and each injustice I have to deal with. All throughout the day I must clear my nose and throat of mucus which is usually yellow to green, (since Covid 19').

DISABILITIES:

CONSCIOUSNESS; Constantly very tired and slight of breath with a pain in my chest.

HEAD; Constant headaches and nausia with both increasing with motion.

THROAT; It hurts to swallow and I must take a sip of water every time and, food gets stuck in my throat and sometimes at my stomach opening and only clears after a few minutes of great pain.

INTESTINAL; I have to use the bathroom with great urgency when I must.

HIP (Left side); It hurts to use stairs and ladders or put much of a load on my left hip.

I stand all day as it hurts to sit unless my left hip/leg is parallel with my body.

SKELETAL; Hands, elbows, knees, feet and left bunion hurt.

PAIN; In pain all of the time from head to foot.
