# GDPR & DATA PROTECTION

The General Data Protection Regulation (GDPR) is a global data protection law that mandates strict guidelines for businesses handling personal data whether that be documentation or electronic devices holding data. Compliance is crucial, as non-compliance can lead to severe penalties. Partnering with a data handler through a contractual agreement ensures GDPR compliance by outlining responsibilities for secure data processing. This approach helps businesses mitigate risks, protect individuals' privacy rights, and uphold data protection standards.



Fines increased from £50,000 to £17,000,000 or 4% of global turnover, whichever is larger.



When an individual requests their data be deleted, this must be done & evidenced within 28 days.



The ICO recommends to destroy all data within a 28-day period, after marked for disposal.



There must be a written contract of agreement with any data processors you use.



You must be able to evidence every step of the data process, including destruction.
