<p>Representation at Appeal Hearings: If, after having a discussion with SAAS about your case, you wish us to represent you at your Appeal Hearing (subject to location and whether in-person or virtual Appeal), the following charges are applicable.</p>	<ul style="list-style-type: none"> • For an in-person Appeal Hearing: £500 (plus travel expenses where applicable). • For a virtual Appeal Hearing: £350. • In either case, payment must be made upfront.
<p>Complete package (Consultation / Case drafting and representation): If you would prefer a complete package which includes all of the above services, SAAS can provide such a service as follows: -</p>	<ul style="list-style-type: none"> • For an in-person Appeal Hearing: £1000 (plus travel expenses where applicable). • For a virtual Appeal Hearing: £875. • In either case, payment must be made upfront.
