Previously Provisional Recognition has been accorded to the classes VI to X (EM) of Sri Bhavani Vidyaniketan, Mosayyapeta, Atchutapuram (M), Visakhapatnam during the year 2011-2012 to 2015-2016 in Proceedings Rc.No.4239/A2/2011 Dt.21.11.2011 of the Regional Joint Director of School Education, Kakinada in the reference 5<sup>th</sup> cited. The Correspondent has submitted the application for **Renewal of Recognition** for the classes VI to X (EM) in the school for the years from **2016-17 to 2025-26**. The District Educational Officer, Visakhapatnam District has verified the application for **Renewal of Recognition** with reference to the Inspection Report of the Inspecting Officer and as per the G.O.Ms.No.1 Education, Dated.01.01.1994. Under Rule 3 (2) of G.O.Ms.No.1 Education, Dated.01.01.1994, the Regional Joint Director of School Education, Kakinada, competent authority for Secondary Schools hereby accords **Renewal of Recognition** for a period of **10 (Ten)** years i.e., for the academic years from **2016-17 to 2025-26** for the classes **VI - X (EM)** subject to fulfillment of the following conditions in Sri Bhavani Vidyaniketan, Mosayyapeta, Atchutapuram (M), Visakhapatnam - Renewal of Recognition

1. That the society shall abide by the instructions / rules and regulations made by the Government or authorized officer from the time to time.
2. That the Educational Institutions shall serve the needs of the locality more particularly.
3. The institution shall adopt the curriculum and syllabus prescribed by the Government from time to time.
4. That the school timing vacations and mid-term holidays shall be followed as prescribed by Government from time to time.
5. That the qualified staff within the age limits prescribed by Government for Government employees shall be appointed with the management own funds as per staff pattern.
6. That the results of institution shall be satisfactory every year.
7. That the records / accounts shall be furnished to the District Educational Officer, every year by 30<sup>th</sup> September at least.
8. That the list of Governing Body shall be furnished to the District Educational Officer every year.
9. That the pay structure / fee structure fixed by the Governing Body shall be got approved by the District Educational Officer every year.
10. That all the conditions prescribed in the G.O.'s and other orders which are not specified in this order shall be complied with.
11. That the school shall not be closed without giving notice both to the parents / District Educational Officer and competent authority at least six months before.
12. That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
13. That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., At least six months prior to the date of expiry of the present recognition.
14. That the society shall provide fire safety measures in the school as per the No Objection Certificate.
15. The management informed that no thatched roof accommodation is allowed to run the School.
16. Proper and adequate Toilets / sanitation facility shall be provided for students especially for girl students.
17. Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
18. The school shall follow the traffic and safety guidelines indicated by the Police and fire services departments.
19. The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
20. The school shall have first aid kit and the teachers shall be trained in first aid.
21. The Correspondent of the concerned school is hereby informed to file an affidavit by April 30<sup>th</sup> of every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
22. That the management shall obtain and submit the structural soundness certificate every year before reopening of the school for the academic year to the Inspecting Officer concerned without fail.
23. That the management shall ensure the Accountants of this school audited by an authorized Chartered Accountant every year and submit.
24. That the management has to maintain trained teachers at all time.
25. The management is informed to follow the guidelines issued in G.O.Ms.No.91 Education, Dated.06.08.2009 regarding Fee Structure in Private Schools.
26. That the Management of the school is informed to obtain the Occupancy Clearance from the Fire Services Department concerned for the complete period of recognition now accorded without fail as the present Occupancy Clearance in the Fire NOC.
27. That the Recognition now granted is subject to genuineness of the Fire No Objection Certificate issued by the Fire Service Department concerned.
28. That the Management of the school is informed to obtain the Structural Soundness Certificate for the Executive Engineer, R&B / Panchayat Raj immediately and submit the same to this office.
29. That the management of the school is informed to extend the lease period up to 31.05.2021 for school building and also for play area and submit to this office within one month without fail

If the management fails to comply with the above conditions promptly, the Recognition now granted will be reviewed.

Previously Opening Permission has been granted for the classes I to V under (English Medium) for the years from 2011-12 to 2015-16 to Sri Bhavani Vidya Nikethan School, Mosayyapeta, Atchutapuram mandal, Visakhapatnam in the reference 1st cited.

The Correspondent, Sri Bhavani Vidya Nikethan School, Mosayyapeta, Atchutapuram mandal, Visakhapatnam (Regd.No.712/2002) has submitted the application for granting of Temporary Recognition for the classes I to V (EM) for the years from 2016-17 to 2025-26 in the reference 2nd cited.

The Mandal Educational Officer, Atchutapuram has verified the proposals with reference to the conditions laid down in the previous orders and G.O.Ms.No.1 Edn.   - 5 That the results of Institution shall be satisfactory every year.
  - 6 That the records/ accounts shall be furnished to the District Educational Officer, every year by 30<sup>th</sup> September at least.
  - 7 That the list of Governing Body shall be furnished to the District Educational Officer, every year.
  - 8 That the pay structure/fee structure fixed by the Governing Body shall be got approved by the District Educational Officer, every year.
  - 9 That all the conditions prescribed in the G.O.s and other orders which are not specified in this order shall be complied with at least six months before.
  - 10 That the school shall be closed or permitted to be closed only from the date which summer vacation is declared.
  - 11 That the society shall submit proposal for Renewal of recognition sufficiently in advance i.e., at least six months prior to the date of expiry of the present recognition.
  - 12 That the society shall provide fire safety measures in the school as per the No objection certificate.
  - 13 The management informed that no thatched roof accommodation is allowed to run the school.
  - 14 Proper and adequate sanitation facility shall be provided for students especially for girl students.
  - 15 Proper and adequate safety measures shall be taken for children within the school campus and also near the school premises.
  - 16 The school shall follow the traffic and safety guidelines indicated by the police and fire services departments.
  - 17 The parent Teachers Associations meeting shall be conducted to sensitize the parents on the safety of the children.
  - 18 The school shall have first aid kit and the teachers shall be trained in first aid.
  - 19 The Correspondent of the concerned school is hereby informed to file and affidavit every year to the effect that there is no deviation or violation of norms prescribed by the Government from time to time.
  - 20 That the management shall obtain and submit the structural soundness certificate every year before reopening of the School for the academic year.
  - 21 That the management shall take every responsibility for the timely safety and comfortable mobility of the School Children from the residences to School and vice versa.
  - 22 That the School Van should be ensured road worthy for the transportation/ mobility of School Children.
  - 23 That the School Bus should be free from all taxes due and should be maintained with regular checks by authorized mechanism of periodically/as and when required without causing any sort of dislocation for the School Children opting the bus facility.
  - 24 That the management shall engage skilled experienced and authorized drivers having good health and good vision for the School Van.
  - 25 That the management shall ensure the vehicle and safety girls be provided to the windows of the Vehicle.
  - 26 That the management shall ensure the Accounts of the School audited by an authorized Chartered Accountant every year and submit.
  - 27 The management shall have to follow the rules and guidelines issued to G.O.Ms No.91/Edn., dated 06-08-2009 and also the provisions of RTE Act regarding fee structure and in other matters.
  - 28 The management is hereby informed that the recognition is being given purely on temporary basis and is subject to the report of state level inspection and vigilance committee regarding fulfillment of all the pre-requisite conditions under A.P. Education Act 1982 and if later found that the school has not fulfilled any pre-requisites as stipulated, the recognition now being given is liable to be withdrawn at once.
  - 29 The Management is instructed to display the fee structure and qualification of the teachers without fail.
  - 30 If the management fails to comply with the above conditions promptly the Recognition now granted will be reviewed.
