# The World Government Movement

Human civilizations have seen innumerable confrontations. World has witnessed two global wars. Vulgar display of nuclear prowess caused unbelievable pain and misery. Desire to subjugate and conquer continues to this day. All this necessitates formation of a democratic governance model at global level. Another attempt was made in 1945, as earlier attempts had miserably failed. This was in the form of "San Francisco Conference" which resulted in the formation of the United Nations (UN). The UN was believed to be a precursor to emerging World Federation leading to a World Government. The world today, is a global village. Needs of countries devolved absolute-independence have into democratic-interdependence while retaining their sovereign identities. A democratic global governance system or precisely a democratic world government has become absolutely necessary now.

A substantive history of the world government movement is more than one hundred years old and history of the Provisional World Parliament, which goes back to 1960s.

Parliament World Constitution and formed Association, Constituent a Assembly in 1968 Sponsored the process of drafting and revising the Earth Constitution, resulted in a historic document and holistic solution for the progress of humanity. The Constitution for the Federation of Earth was written through the combined effort and input of hundreds of world citizens, including many international legal experts

over a period of 23 years (from 1968 to 1991). At the first Constituent Assembly in Interlaken, Switzerland in 1968, the delegates elected a drafting committee of 25 persons, which included a prominent



Indian Mr. Godey Murahari, former Deputy Chairperson of Rajya Sabha. In 1972, this committee completed the first draft and was circulated worldwide several times for comments and amendments. It was reviewed paragraph-by-paragraph and adopted at the Second Constituent Assembly in Innsbruck, Austria in 1977. Small changes were made at the Third assembly and at the Fourth Constituent Assembly in Troia, Portugal in 1991 declared the Earth Constitution "completed" and ready for by the people and nations of Earth.

#### First Session of PWP-1982



First Session of Provisional World Parliament meets at Brighton, England. Delegates form 25 countries of 6 continents.

Five world Legislative Acts are adopted: for World Disarmament Agency, World Economic Development, Ownership of Oceans & Sea-beds, Graduate School of World Problems, and World Courts.

#### Second Session of PWP-1985



1985. Second Session of Provisional World Parliament held New Delhi, India. Opened by President of India, presided by speaker of Lok Sabha. Three more World Legislative Acts adopted: for Emergency Earth Rescue Administration, World Government Funding, and Commission on Terrorism.

#### **Third Session of PWP-1987**



1987. Third session of Provisional World Parliament held Miami Beach, Florida. Three more World Legislative Acts are adopted: for Global Finance System, Environment Protection, and Hydrogen Energy.

#### Fourth Session of PWP-1996

The Fourth Session of the Provisional World Parliament held at Barcelona, Spain in



September. A number of resolutions passed as well as a "Manifesto" declaring the oceans the property of the people of Earth under the authority of the Earth Constitution.

## Fifth Session of PWP-2000



2000. The Fifth Session of the Provisional World Parliament is held on the Island of Malta, November 22nd to 27th. One Omnibus legislative act and a number of resolutions passed.

## Sixth Session of PWP-2003

The Sixth Session of the Provisional World Parliament held in Bangkok, Thailand,



March 23rd to 28th. Several important legislative acts passed: a World Peace Act, a World Security Act, a Provisional Office of World Revenue Act, a Hydrocarbon Resource Act, and a Statute for the World Court on Human Rights. The Commission for Legislative Review is formed. Parliamentary law format commences with the Sixth Session.

#### Seventh Session of PWP-2003



The Seventh Session of the Provisional World Parliament is held at Chennai, India, December 23-29. Several important legislative acts passed: a Criminal Penalty Code, Rules for Procedure and Evidence, a World Bench for Criminal Cases Act, a World Patents Act, a Global Accounting and Auditing Standards Act, and a Preservation of World Government Records Act. The Manifesto of the Earth Federation and the "Pledge of Allegiance to the Earth Constitution" are unamimously ratified by the Parliament.

## **Eighth Session of PWP-2004**

The Eighth Session of the Provisional World Parliament held at Lucknow, India



in August. Several important legislative acts passed, including creation of a World Bench for Juvenile Cases, a Child Rights Act, an Elections Act, and a Water Act. The International Criminal Court in the Hague is empowered by world legislation.

A global Education Act is passed as well as a World Economic Equity Act establishing the Earth Currency on an independent and fully democratic basis. A Global People's Assembly is created to activate grass roots participation in the House of Peoples. The "Declaration on the Rights of Peoples" is unanimously ratified.

#### Ninth Session of PWP 2006

Ninth Session of the Provisional World Parliament to be held in Libya, Africa, February-March, 2006.



## **Tenth Session of PWP**

The Tenth Session of the Provisional World Parliament held in Kara, Togo in June. Four world legislative acts are passed: an act prohibiting unauthorized destruction of illegal financial instruments, an act creating a system of divestment from illegal weapons manufacture, an act requiring posting of



the world illegal stock law in stock exchanges around the world, and an act providing a guaranteed annual income for all adults within the Earth Federation.

## **Eleventh Session of PWP**

The Eleventh Session of the Provisional World Parliament held in Nainital, India , July 2-8, 2009. Several world legislative Acts



were passed into provisional world law, including a procedure for the dismantling of nuclear weapons, a law protecting the people of Earth from too much bureaucracy in the world government, an act criminalizing human trafficking for sexual or other purposes, an act abolishing all secret intelligence agencies like the CIA, M5 or Mossad, a bill elaborating the restrictions on the military uses of depleted uranium, and a law protecting the right of civil disobedience for the people of Earth under the Earth Federation (included in this volume). The delegation from Bangladesh presented the parliament with a new translation of the Constitution into its 23rd language: Bengali or Bangla.

## **Twelveth Session of PWP**



2011. December-January. The Twelfth Session of the Provisional World Parliament

takes place in Kolkata, India. The Parliament meets within the context of the giant World Peace Thinkers and Poets Meet Conference sponsored by the World Constitution (WCPA), the International Society for Intercultural Study and Research (ISISAR), and other organizations.

#### **Thirteenth Session of PWP-2013**



2013. December 19-21, Lucknow, India. The Thirteenth Session of the Provisional World Parliament took place simultaneously with the International Conference of Chief Justices of the World at the World Unity Convention Center of the City Montessori School of Lucknow.

A number of key world legislative acts were passed, including a Transition Act to facilitate countries joining the Earth Federation and a Truth and Reconciliation Act.

## Fourteenth Session of PWP-2014

14th session of the Provisional World Parliament was held in Kolkata, India during December 2015. Plans for the promotion of the Earth Constitution as a subject of study and as an item in the

educational curriculum of institutions



everywhere in the world was discussed. Work on the Collegium of World Judges and the constitution of a bench of the World Supreme Court were also discussed

#### Fifteenth Session of PWP-2021



15th PWP was held in Hybrid mode due to covid pandemic restrictions. Event was held from our office premises and faciliated by Maj Sushil Goel and his team.

Hundreds of participants joined virtually from various parts of the world.
