On 070714 about 0200 hours, I was dispatched to 3949 Willowood Avenue for a loud verbal argument in the back yard. I arrived on scene and was told that kids were jumping the back fence to hide from us.

I observed several kids go over the fence and saw broken fence parts lying in the back yard of 3949 Willowood. I knocked on the door and heard more people run out the back of the house and the lights inside the house were shut off. I was at the house earlier in the evening (070714 0015 hours) for a noise complaint so I knew the homeowner was LINCOLN SCHULTZ. I told SCHULTZ he needed to shut the party down and if I had to return he would receive a summons for noise. SCHULTZ said he understood and said that I would not have to come back.

Officer Kevin Havel and I knocked on the door and shouted for SCHULTZ to come to the door. We did not receive an initial answer at the door so I called the homeowner and grandfather of SCHULTZ, GLENN SCHULTZ. I did not receive an answer so I left a message asking GLENN to call me back.

Officer Havel and I went back to the house and knocked on the door again. SCHULTZ finally answered the door and I told him he would be receiving a summons for the noise disturbance. I walked back to my vehicle to get my ticket book and when I was returning to the scene Officer Havel called out a disturbance on the north side of 3949 Willowood Avenue. Officer Havel said the neighbor had one kid in his back yard at gun point. I then heard Officer Havel yell that the kid took off running. I heard a male running through the rocks on the south side of 3949 Willowood Avenue. I confronted the male (later identified as JESSE JAMES MORRISON) and ordered him to the ground. I placed MORRISON in protective custody and walked him back to the door step of 3949 Willowood Avenue. MORRISON identified himself to me as JESSE JAMES BUSTEMONTE, DOB 112895.

I explained to SCHULTZ and MORRISON that they would both receive summons and SCHULTZ would get a First Notice for Noise Disturbance. SCHULTZ and MORRISON said they understood. While I wrote the summons I could hear yelling and loud banging coming from the house. I told SCHULTZ that the noise had to stop. I told him no tickets would be issued but he needed to tell everybody to leave. SCHULTZ refused and said we could not enter his house.

I issued SCHULTZ a summons for noise and underage consumption of alcohol. SCHULTZ said we could not prove he was drinking because he did not take a test and he would not take a test. Officer Havel and I told SCHULTZ that we did not need a test because we could smell the alcohol on his breath and SCHULTZ admitted to me at my prior visit that he had been drinking. I told SCHULTZ that I warned him earlier and he refused to listen so he would receive the summons. SCHULTZ said we could not prove he was drinking alcohol so he would not sign the summons. I explained the summons to SCHULTZ and wrote refused to sign by his signature.

I spoke to GLENN SCHULTZ on the phone and explained what was going on at his house and he told me that he wanted everyone out of the house. GLENN SCHULTZ told me that I had permission to enter his home. SCHULTZ said he did not want us to enter the house and he spoke to GLENN SCHULTZ on the phone. GLENN SCHULTZ changed his mind and said he did not want us to go into his house.

Officer Havel was starting a summons for MORRISON. Officer Havel ran MORRISON'S name through dispatch. MORRISON got up and went into the house and shut the door. MORRISON refused to come out of the house. Dispatch came back stating that the name, JESSE

BUSTEMONTE, came back not on file. Sergeant Brandon Johnson found information on MORRISON on his in-car computer. Sgt. Johnson had a picture and information showing that JESSE BUSTEMONTE was JESSE MORRISON.

Officer Havel announced at the door that we knew MORRISON was inside the house and he needed to come out. SCHULTZ said nobody inside the house was named MORRISON but he knew ADAM MORRISON from school. Officer Havel announced that if MORRISON did not come out then a warrant would be issued for his arrest. MORRISON refused to come outside.

We cleared the scene and I returned to the Loveland Police Department to turn in evidence and paperwork on the call. Sgt. Johnson found MORRISON on Facebook and was able to find several pictures to confirm MORRISON'S identity. In the Facebook pictures was a picture of the red truck that was in the driveway of 3949 Willowood Avenue. The truck plate 073LPQ comes back to a BRYCE and BRIANNA KRAFT. The pictures are attached to report. The summons that was being written for MORRISON was placed into evidence under the false name of JESSE BUSTEMONTE that MORRISON gave me.

## Loveland Police Department

On 070714 at approximately 0201 hours, Officer J. Allen and I responded to a verbal disturbance at 3949 Willowood Avenue, in the city of Loveland. The original report was males were verbally fighting in the backyard of the residence.

Officer Allen and I arrived on scene. Officer Allen told me he was out at the same house earlier in the evening on a noise complaint.

Officer J. Allen and I approached the house. I could hear yelling coming from the backyard. I stood on the south side of the house. I saw a male come around the corner house. He saw me and ran back behind the house. I heard a male yell "Cops are here." I saw several people jumping over the back fence. Officer Allen knocked on the front door. I could hear people moving around the inside the house. The lights inside the house were turned off and everything went quiet.

I walked to the north side of the house. I saw a male, [REDACTED] standing in the backyard of [REDACTED] talking to another male who was standing in the backyard of 3949 Willowood Avenue. I asked PATRICK if everything was okay. [REDACTED] said he lives at [REDACTED]. He said he was tired of all the noise. I asked the male to go inside and tell the homeowner, LINCOLN SHULTZ to come outside. A short time after, LINCOLN came out the front door. Upon contact, LINCOLN was visibly intoxicated. His speech was slurred and I could smell a strong odor of an unknown alcoholic beverage coming from his breath.

While Officer Allen was speaking with LINCOLN, I heard yelling coming from the north side of the house. As I came around the corner, I saw [REDACTED] pointing a handgun at a male, later identified as JESSE MORRISON. I saw JESSE climbing over the fence from [REDACTED] backyard. I told [REDACTED] to put the gun. [REDACTED] lowered his gun to his side. I asked [REDACTED] to go inside and put the gun away, which he did.

JESSE took off running south through the backyard where he was caught by Officer Allen. I walked back to the front of 3949 Willowood Avenue. I asked JESSE for his name and date-of-birth. JESSE initially told me his name was "JESSE BUSTEMONTE" with a date of birth of 112895. Dispatch conducted a routine check of NCIC/CCIC and DOR records which revealed JESSE BUSTEMONTE was no record. Officer Allen stayed at the front of 3961 Willowood Avenue, while I went and spoke with [REDACTED]

I went to [REDACTED] house to get a statement. [REDACTED] told me he has a couple ladders on the south side of his house. He was sitting inside when he heard what sounded like the ladders rattling. He grabbed his .45 caliber handgun and went to investigate. He saw a male (JESSE) crouched down next to his house. [REDACTED] pointed the gun at JESSE and told him to stay there. [REDACTED] said he did not know who it was or what they might be capable of.

[REDACTED] said he had his grandchildren sleeping at his house. He was afraid not only for his safety, but for his grandchildren. [REDACTED] said he wanted to press charges against JESSE for trespassing. [REDACTED] did not want to complete a written statement.

Officer Allen told LINCOLN and JESSE he had consent to go inside the house. JESSE got angry about Officer Allen saying he was going inside. JESSE stood up and walked inside the house. I told LINCOLN to go inside and tell JESSE to come outside. LINCOLN went inside and I heard him calling for JESSE. I asked LINCOLN if JESSE ran out the back of the house. LINCOLN said JESSE might

have left out the back. I told LINCOLN that we know JESSE'S last name is MORISON. I told LINCOLN to tell JESSE MORRISON to come outside and get his summons. LINCOLN said there's no one inside with the name of MORRISON. LINCOLN stated the only person he knows with the name of MORRISON is an ADAM MORRISON from school.

I told LINCOLN if JESSE does not come outside there will be a warrant issued for his arrest. JESSE refused to come outside.

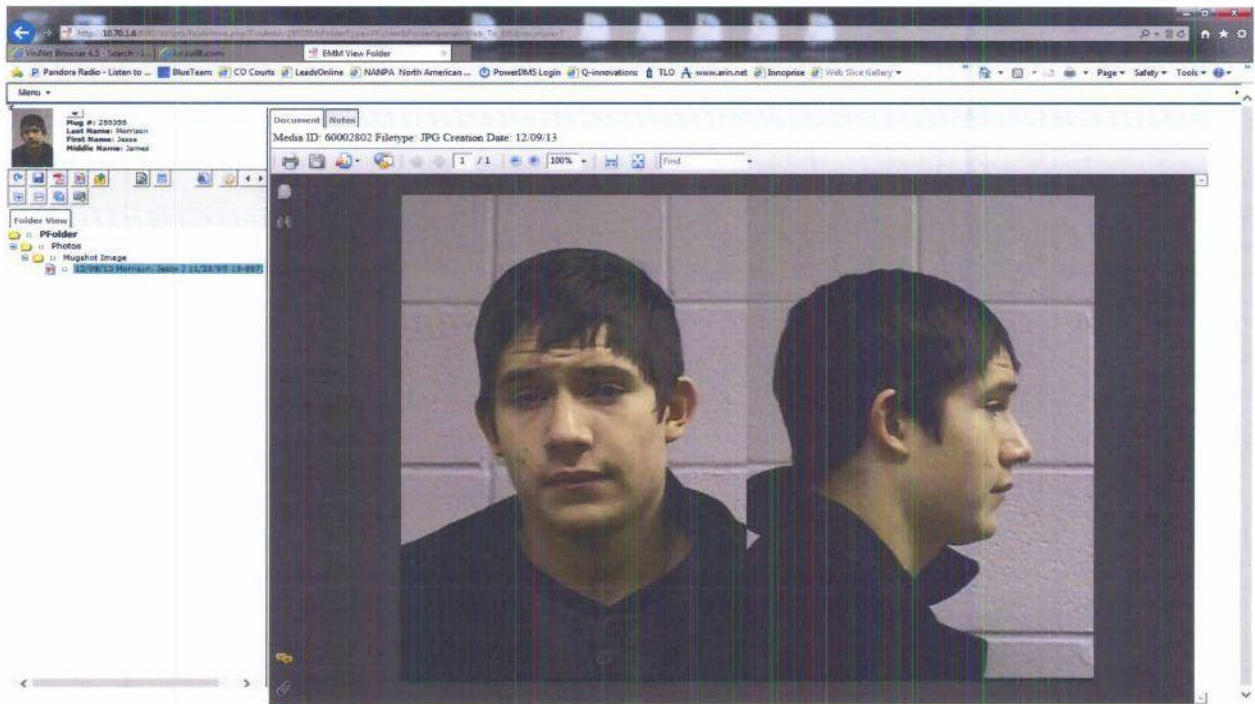

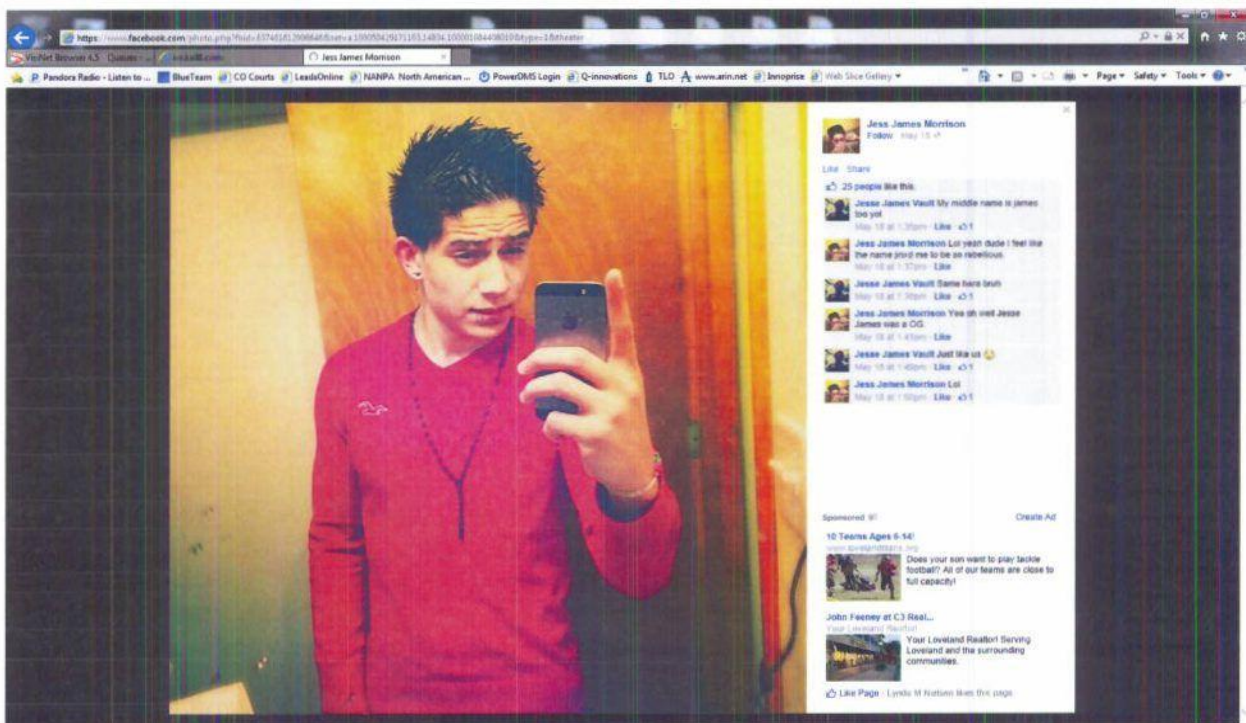
