Officer Denise Dean reporting:

On 070417 at approximately 2259 hours, HEATHER GARRETT called dispatch to report her sister, OKSANA GARRETT, was being chased around Lake Loveland, located at 2800 N Taft Avenue, by her boyfriend, JESSE MORRISON. HEATHER said she received several calls from OKSANA asking her to pick OKSANA up but she didn't get the calls because she was at the fireworks display in Greeley. She then got a phone call from JESSE stating he had chased OKSANA around the lake for 3 miles and had broken her phone so OKSANA couldn't call her.

I drove around the lake but did not see a male chasing a female. At approximately 2315 hours, I was approached by a male on a bicycle stating a small female had asked to use his phone. The male said the female appeared scared and he would like me to keep an eye on her.

I contacted OKSANA walking. She had a visible black eye and was upset. I asked her what happened and she told me JESSE had broken her phone so she couldn't call anyone for help. She pulled out her phone which was so badly broken, it could no longer be used. She said JESSE was driving around with his Mother in her red, Ford SUV but he wouldn't come around her if she was with a police officer because he has multiple warrants. OKSANA said she used a male's cell phone to call HEATHER and she was on her way from Greeley to pick her up.

I drove OKSANA to the gas station that she was supposed to wait for HEATHER at. I stayed with her until HEATHER arrived.

When HEATHER arrived, she hugged OKSANA and asked if she was okay. She then scolded OKSANA for being around JESSE and letting him push her down and break her phone. I told HEATHER that OKSANA did not mention anything about JESSE pushing her down.

OKSANA hesitantly said JESSE had pushed her down on the cement in a driveway because he was mad at her. She said that is how she most likely got the black eye. HEATHER pushed OKSANA'S hair off her back. Her back had road-rash from the altercation.

I took photographs of OKSANA'S injuries and of the broken phone that is valued at \$800. I gave her an Alternatives to Violence pamphlet.

From HEATHER'S phone, OKSANA attempted to call JESSE to see if he would put her belongings on the front porch for her to pick up but JESSE did not answer. HEATHER then called JESSE'S Mother, whom he lives with, and she agreed to put OKSANA'S belongings on the front porch as long as OKSANA never came back.

I cleared JESSE through dispatch. He currently has 4 Misdemeanor warrants and 1 Felony warrant. I contacted Larimer County Sheriff's Department and asked them to attempt contact with JESSE. I have not heard from them as to whether they were able to take him into custody or not.

OKSANA and HEATHER completed Voluntary Witness Statements.

The pictures have been logged into the ADAMS in-house system.
