To whom it may concern,
I Roger Ridd would like to state the purpose of this disposition is to reveal the rules of the quorum, among other rule violations have been and continue to be broken by the current chair, all of the members of the executive committee and other members of the CCLC

I Roger Ridd in good standing with the CCLC on this 7th day of February 2024, hereby swear upon my relationship with God, and the oath I took to protect and enforce our Constitution many a year ago, the following is not allegations but in truth factual. For there many participants and witnesses to what I am revealing below...

In June 2021 there ^{were} 8 preivences against me by a previous chair, two district representatives, a county judge, and the CCLC executive committee of my county.

February 4th 2024

My current chair offered to gather me support by having secret meetings in his own home to bring the truth out about my situation. I agreed but did not attend that first meeting. Since that time I have attended a couple of other of these meetings on other issues within the CERC.

Basically character assassination to whip the votes on issues within the CERC.

I was a member of the executive committee (3rd vice chair) during all of the above.

I have not participated in these meetings which I know for a fact continued to 10/2023 or 11/2023.

These secret meetings conducted by the current chairman, and many current members of the committee to include all of the current executive committee discussed CERC business, were held specifically to influence and shape, and indeed to gain control of the CERC. In fact, one such meeting I attended at Barry Eggar's home was for the purpose deciding who would be on the county executive committee, what positions each individual who hold, and to ensure enough votes

to get the desired results. Neither then
chair, Jon Mulligan nor future chair
Brandt Smith were present at this illegal
meeting.

I stopped participating and in these
meetings when I became parliamentarian in
January 2023, I found out through R.P.A.
Rules they are actual quorums. Illegal
quorums according to the R.P.A. Rules.

I am ready to attest to the truthfulness
of this statement, and willing to answer
questions pertaining to this or any other
matter to which I have direct knowledge.
