Complaint

To: District Chairman, 1st Congressional District RPA

Re: Darren Waddles, 1st Congressional District Secretary

Madame Chair,

Based upon the attached evidence, the current District Secretary, has worked against the interests of the Republican Party. The evidence attached includes a police report, screenshots, videos, witness testimony and other supportive documentations.

This complaint presents two documented issues of Darren Waddles' seriously, inappropriate behavior and associations.

1. As teacher at Mountain View Arkansas High School, Darren police report and screenshots of inappropriate snapchats he carried on with with a sixteen year old student. These are incriminating images and messages by Mr Waddles with the minor child while he was in a position of authority as a teacher. Furthermore, on the police report, he admitted such inappropriate texting/snapchatting, and thus resigned from his job as a teacher. In his admission, he stated that he was intoxicated at the time, yet there were multiple occasions of snapchatting with this minor. Subsequently, he was able to get a job at Midland High School in Pleasant Plains, but soon resigned from that job when the school administration was alerted to his previous actions with the minor child student.

2. While Darren Waddles was living in Jacksonville Arkansas with his grandparents Linda and Charles Dyson, Tai Shen Kuo, a Chinese business partner of his grandmother who, according to a family member witness, was paroled from prison and was also living with in the Dyson household. On weekends, Darren and Mr Kuo, came to stay at his stepfather and mother's home in Mountain View, Arkansas. As presented in the attached CBS 60 Minutes show, Mr Kuo was filmed buying and selling classified US defense secrets to the People's Republic of China. He was indicted, sentenced to prison for espionage for fifteen years. According to the the family member witness, after prison he was paroled to the Dyson home who helped Mr Kuo find employment. The many levels of this connection strongly suggest that Darren Waddles and his grandmother should not have access to elected officials and Party leadership.

The witness also states that Darren Waddles was caught with the minor child at the school, and more to the story that the police report indicates that forced Mr Waddles to resign from his teaching position. However, the redacted police report does not reflect that information.

Individually, either of these actions are absolutely working against the interests of our Party. Protecting our children and our country cannot be compromised or ignored. Our Party does not need this blight on our reputation by appearing to condone these actions toward children and against our country. I request that these charges be investigated and that Darren Waddles be removed from his District position. Thank you for your attention to this matter.

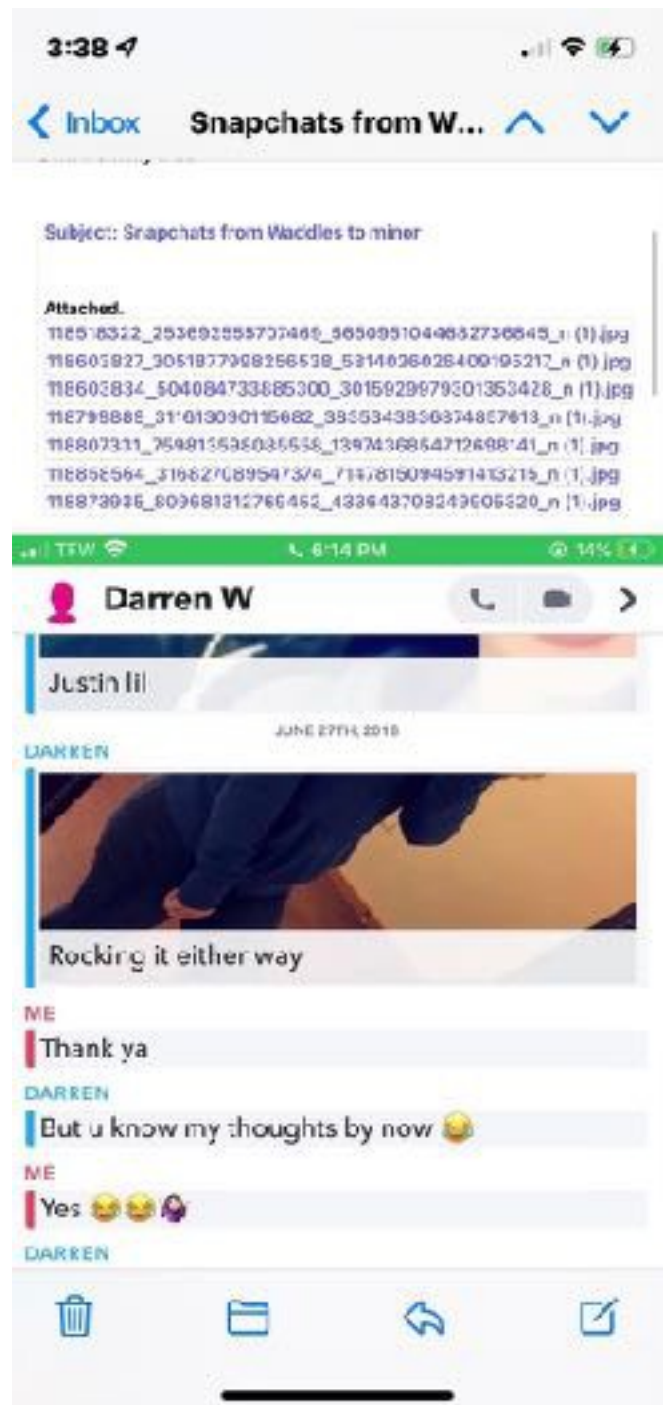
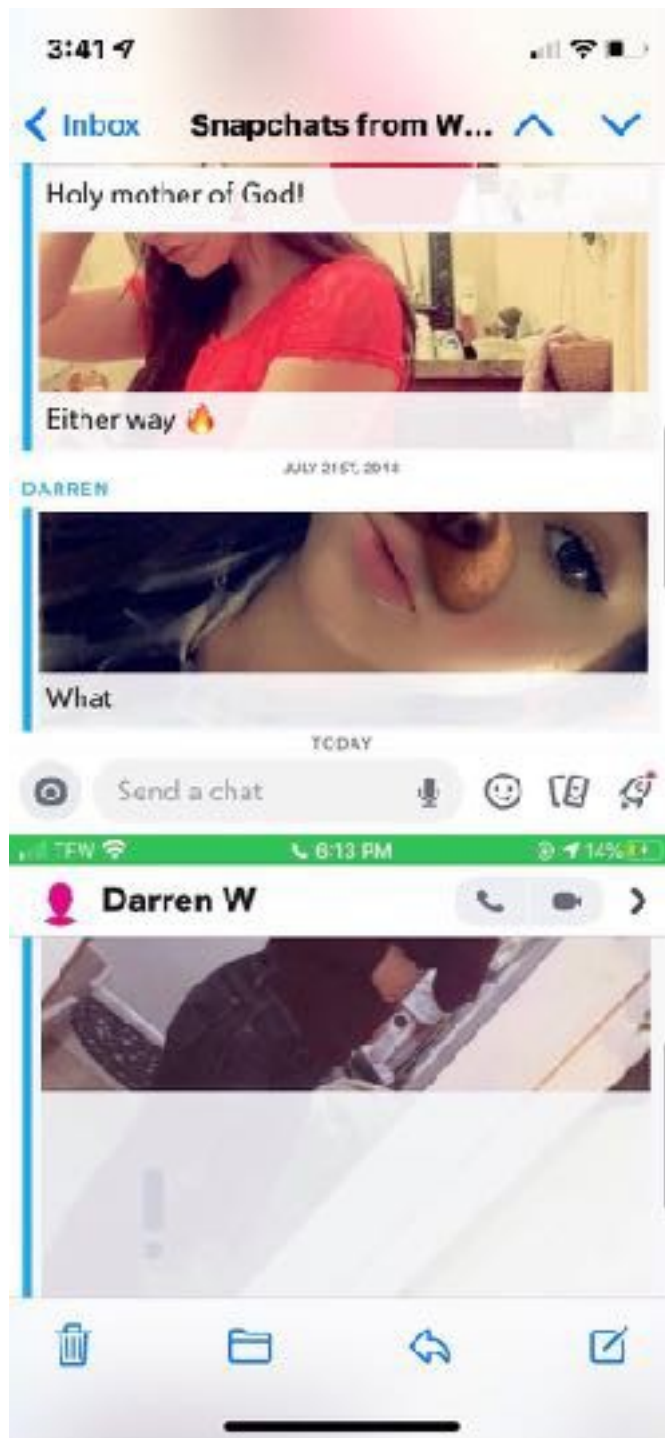

A fax was received from CACD concerning this case.

Narrative - Beaudin, Jeremy M - 4/17/2019 (Initial)

I met with Investigator McKenzie Jackson of ASP. We went to the MV School and conducted numerous interviews with staff and students to determine if the allegations in the report were true or not. After discussion with them we were lead to a former student B Vallery who had moved to Cave City Schools. McKenzie Jackson made contact with her and was able to conduct an interview at the CID building at the Stone County Sheriff's Office. Following his interview he contacted me and we discussed what he learned and also he received photos of chats between Waddles and herself. Waddles was called in and an interview was conducted with McKenzie Jackson, Mr. Waddles and myself. Waddles was asked about the messages and stated at one point he was intoxicated and said something he shouldn't have but then realized it and stopped the conversation. He stated that he resigned based on that incident and didn't want to make things worse.

New Orleans Man Sentenced to More Than 15 Years in Prison for Espionage Involving China

WASHINGTON -- Tai Shen Kuo, age 58, of New Orleans, Louisiana, was sentenced today in the Eastern District of Virginia to 188 months in prison and required to forfeit \$40,000 for conspiracy to deliver national defense information to a foreign government, namely, the People's Republic of China (PRC), in violation of 18 U.S.C., Section 794(a), (c). Kuo pleaded guilty to this offense on May 13, 2008, after being arrested on February 11, 2008.

Patrick Rowan, Acting Assistant Attorney General for National Security; U.S. Attorney Chuck Rosenberg of the Eastern District of Virginia; and Arthur M. Cummings, II, Executive Assistant Director of the FBI's National Security Branch, made the announcement after U.S. District Judge Leonie M. Brinkema imposed the sentence.

According to a Statement of Facts filed in Court with Kuo's Plea Agreement, the criminal conduct spanned the time period of March 2007 to February 2008. During this time, Kuo, a naturalized U.S. citizen, obtained national defense information from Gregg W. Bergersen – a Weapons Systems Policy Analyst at the Arlington, Va.-based Defense Security Cooperation Agency, an agency within the Department of Defense – on several occasions. The information pertained primarily to U.S. military sales to Taiwan and U.S. military communications security and was classified at the Secret level.

During the course of the conspiracy, Kuo cultivated a friendship with Bergersen, bestowing on him gifts, cash payments, dinners, and trips to such places as Las Vegas. Kuo also led Bergersen to believe that he would make Bergersen a part owner or an employee of a company selling U.S. defense technology to Taiwan after Bergersen's retirement from government service.

Unbeknownst to Bergersen, Kuo passed along to an official of the government of the PRC the documents and information Bergersen had provided him. The PRC official directed Kuo to collect specific documents and information and paid him approximately \$50,000.00 for completing those tasks.

On July 11, 2008, Bergersen was sentenced to 57 months in prison and three years supervised release after pleading guilty on March 31, 2008 to conspiracy to deliver national defense information to a person not entitled to receive it, in violation of 18 U.S.C. Section 793(d), (g).

On August 1, 2008, Yu Xin Kang, a co-conspirator in the case, was sentenced to 18 months in prison for aiding and abetting an unregistered agent of a foreign government, namely the PRC. Kang pleaded guilty to this offense on May 28, 2008.

The investigation was conducted by the FBI. The Air Force Office of Special Investigations (OSI) provided substantial assistance and cooperation throughout the course of the investigation.

The prosecution is being handled by Assistant U.S. Attorneys Neil Hammerstrom and Aaron Zebley from the U.S. Attorney's Office for the Eastern District of Virginia, and Trial Attorney Ryan Fayhee from the Counterespionage Section of the Justice Department's National Security Division.

JUDGMENT

On this 28 day of July, 2015, the defendant appeared before the Court with without counsel on the charge of Harassment

and
having been informed of the nature of the charges against him/her and of his/her constitutional right and legal rights, the Court made the following findings:

You have pled guilty, not guilty, or nolo contendere. You have been found guilty of the offense of Harassment

You are being sentenced to do the following:

Affidavit of Witness

I, Bradley Griffith, a resident of Mountain View, Arkansas, do hereby state THAT:

1. As married into the Dyson family, I was present and a witness to the listed details in the June 30, 2022 complaint of my stepson Darren Waddles.
2. Darren Waddles was a teacher at the Mountain View High School and I became aware of his inappropriate text/snapchatting with a 16 year old female student. I provided copies of a few of those interactions that are listed in the Darren Waddles complaint.
3. I was present and I witnessed the Dyson family, including Darren Waddles, discussing, arguing and the family's actions related to the paroling of the Chinese spy Tai Shen Kuo into the Linda and Charles Dyson family home in Jacksonville, Arkansas. The discussions were about the concern that Mr Kuo was convicted of espionage against the US Government as well as a business partner of Linda Dyson.
4. I experienced the Dyson family attempting to pull me into the matters surrounding their support of Mr Kuo.
5. Darren Waddles also lived in the Dyson's Jacksonville home while attending school. For over a year or more, Darren Waddles frequently brought Tai Shen Kuo on weekends to my home in Mountain View, Arkansas.
6. I witnessed many poor character choices that I consider crossing an obvious moral line, especially for a person who has an authority position as a high school teacher and a political representative interacting with our government leaders.
7. I am available to share many detailed examples I witnessed and statements told to me by Darren Waddles.
8. I am presenting this affidavit to attest to the truthfulness of the foregoing facts and to support the information provided in the 6-30-2022 complaint.
