### 1. Policy Statement

### 2. Objectives

- To establish proactive, transparent, and respectful relationships with local communities
- To contribute positively to local economic and social development
- To ensure that community concerns, expectations, and rights are recognized and addressed
- To minimize and mitigate the social and environmental impacts of our operations
- To align our efforts with national development goals and local aspirations

# 3. Guiding Principles

Our approach to community involvement is guided by:

- Respect: Recognizing the customs, cultures, and values of local communities
- Inclusion: Ensuring broad-based community participation, including women, youth, and vulnerable groups
- Partnership: Collaborating with traditional authorities, district assemblies, civil society, and local institutions
- Transparency: Providing clear and honest communication about our activities, impacts, and commitments
- Accountability: Monitoring and reporting on community-related performance and outcomes

# 4. Community Engagement Framework

Nicdox shall adopt the following mechanisms for structured community engagement:

#### a) Stakeholder Identification & Mapping


 Identify all relevant local stakeholders, including traditional leaders, assembly members, local NGOs, youth and women's groups, farmers, and opinion leaders.

# b) Community Consultations

Conduct regular dialogue sessions, durbars, town halls, and focus group discussions before, during, and after project phases.

# c) Community Liaison Officers

Appoint trained community liaison officers (CLOs) at operational sites to serve as the bridge between Nicdox and host communities.

### d) Grievance Mechanism

 Maintain an accessible and fair grievance redress system to handle community concerns in a timely and respectful manner.

# **5. Community Development Commitment**

Nicdox will actively support local development through:

#### a) Employment and Local Hiring

- Prioritize recruitment of qualified community members for skilled and unskilled roles.
- Provide apprenticeship and internship programs for local youth.

# b) Capacity Building

- Offer training programs in areas such as:
  - Vocational and technical skills
  - o Safety and environmental awareness
  - o Entrepreneurship and business management

# c) Local Procurement

Give preference to local businesses, vendors, and suppliers where they meet quality and safety standards.

# d) Infrastructure and Social Investment

- Partner with communities and local governments to invest in:
  - o Clean water and sanitation
  - Roads and transportation
  - Health and education facilities
  - o Agricultural and livelihood enhancement projects

#### 6. Cultural and Environmental Stewardship


- Respect sacred sites, cultural heritage, and community traditions.
