This Deed is written in plain, simple English and plain simple counting systems.

This Deed is executed exclusively and inherently within the jurisdiction of Natural Law in which both form and substance are inherent in every case. The Applicable Law is therefore the Law of Equity, the Constitutional Common Law: Legem Terrae; the Law of the Land, of The Territory or place which is specified in the First Schedule.

Private Trusts are recognised and enforceable under English law by virtue of statutory provisions enacted through Acts of Parliament, the Equitable Principles of the Law of Equity, and the doctrines of the Common Law as applied in England and Wales.

I, a wo/man {Settlor-: First-Middle: Last.} as a private wo/man standing under Natural Law, the Law of Equity, the Constitutional Common Law: Legem Terrae, and the Law of the Land of England, and not statutory legislation, state that English Law recognises the existence of Private Trusts, therefore the Express Private Family Discretionary Trust known as the Xylophone Yellow Zebra Private Trust with the references Xylophone-Yellow-Zebra-060425, X-Y-Z-Private-Trust-060425, and X-Y-Z-PT-060425 exists.

The Xylophone Yellow Zebra Private Trust has been created voluntarily and evidenced in writing by the wo/man {Settlor-: First-Middle: Last.} who sometimes acts as the Settlor.

It is clearly stated as an expression of the wo/man {Settlor-: First-Middle: Last.} who sometimes acts as the Settlor, that it is his/her intention to create an Express Private Family Discretionary Trust;

[ii] Certainty of Subject Matter

The subject matter or the specific Trust Res and Property is clearly identified as equitable assets with title number:

[a] TA01-X-Y-Z-PT-060425 which the Trustee is in receipt of, as evidenced by the Royal Mail Special Delivery Tracking Number: {Res1 SD Sticker 2- {AB 1234 5678 2GB}}; and

[iii] Certainty of Objects or Beneficiaries
The Beneficiaries are clearly identified within the expression of the Trust.

These are the three certainties that the courts require to be in place to constitute a valid trust as per the case of Knight v Knight (1840) 3 Beav 148; 49 ER 58.

As a wo/man who sometimes acts as the Settlor, I {Settlor-: First-Middle: Last.} have the right to invoke a Trust as described by LJ Turner in Milroy v Lord (1862) 4 De GF & J 264; 45 ER 1185.
