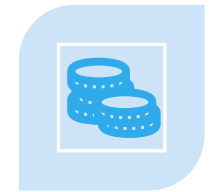

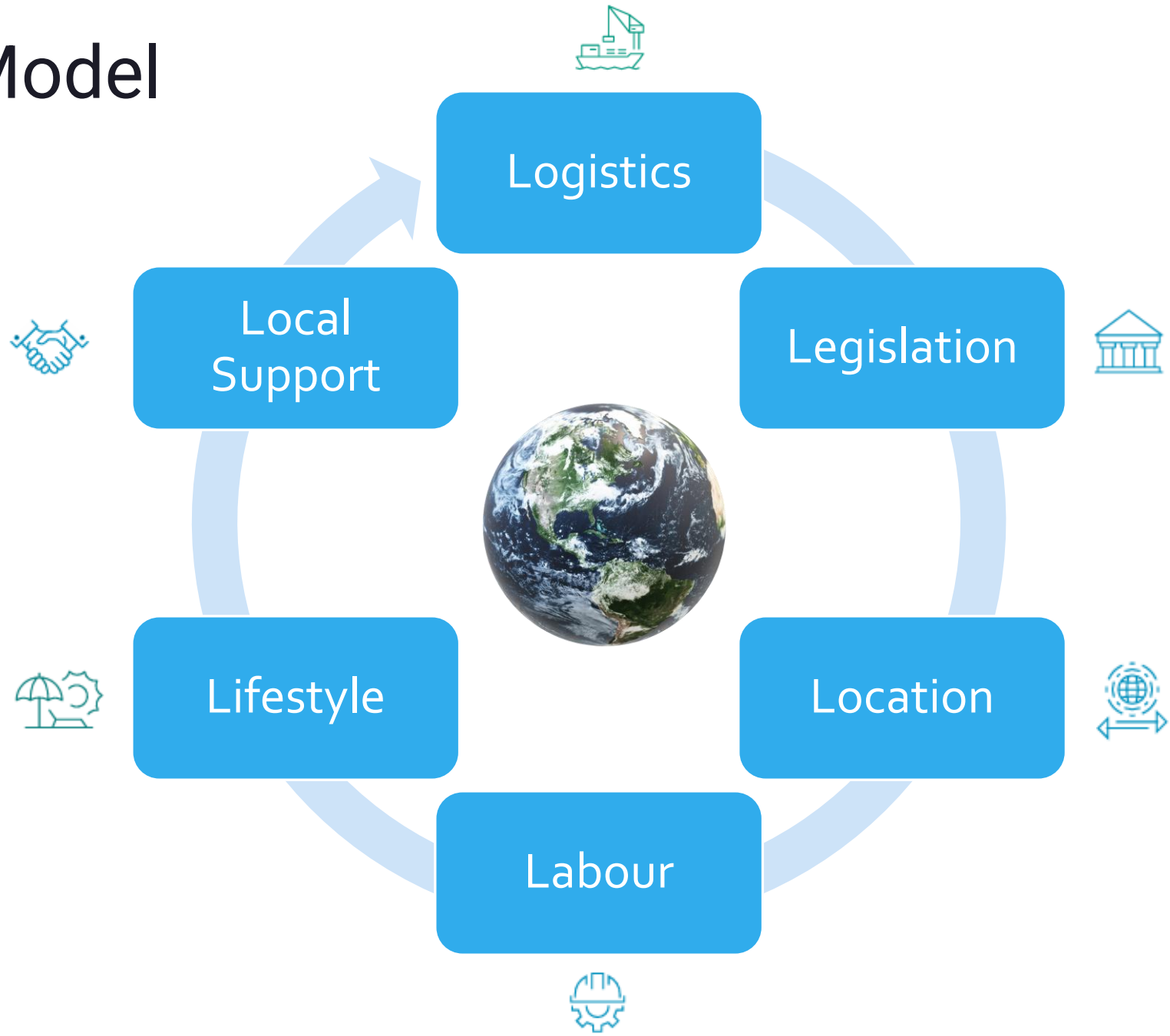

What is a Free Zone?



Basic Economics of a Free Zone

Key to the success of Free Zones is the generation of early cash flow from the rental of basic offices and accommodation spaces

Early costs, including:

- legal to cover the costs of legal documentation with the host government and any associated costs, such as legislation
- Master planning
- Construction of initial office and accommodation blocks
- Marketing;
- Typically, total Circa US\$3 million

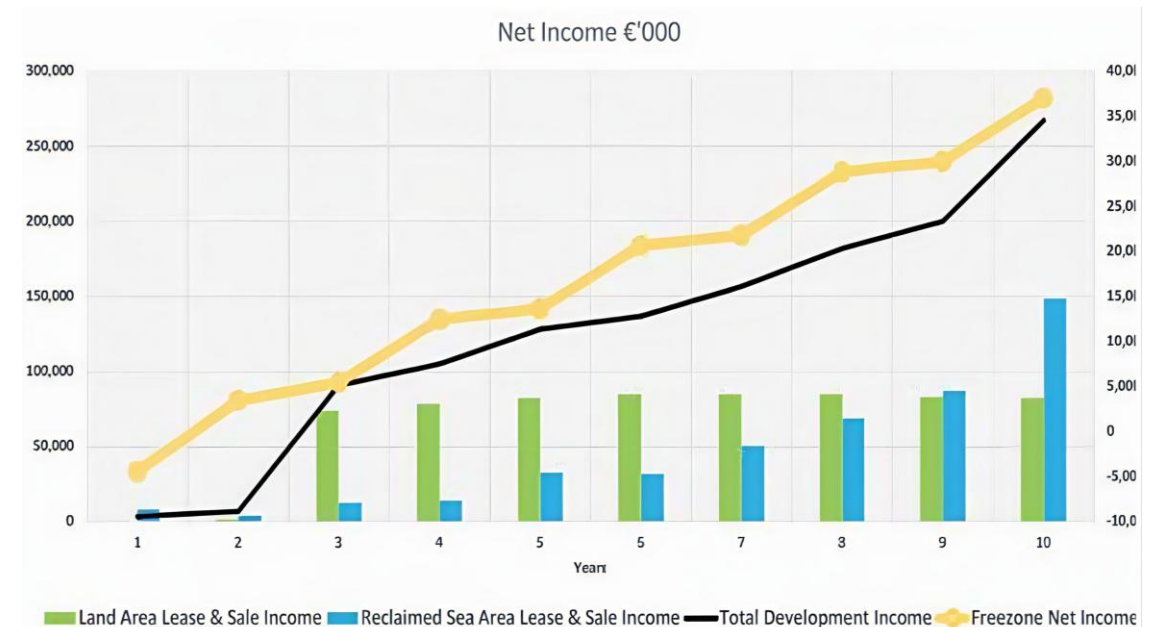
* Experience shows that the payback of these costs is c. 30 months

NB

- Turnover of Ajman FZ in 2017 was \$110 million, based on approximately 8,000 units (offices/apartments)
- Turnover of Ras Al Khaimah FZ in 2017 was \$207 million, off 14,000 units

The chart below shows a typical profile of Free Zone development, showing net income from land development, marine reclamation development and Free Zone development.

In this case, both existing and reclaimed land is split between land leased and land sold, while net income from the Freezone shows steady growth.



What Governments Think?

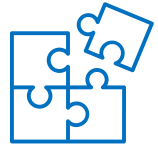

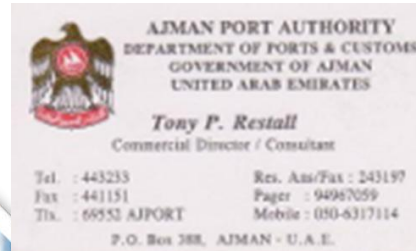

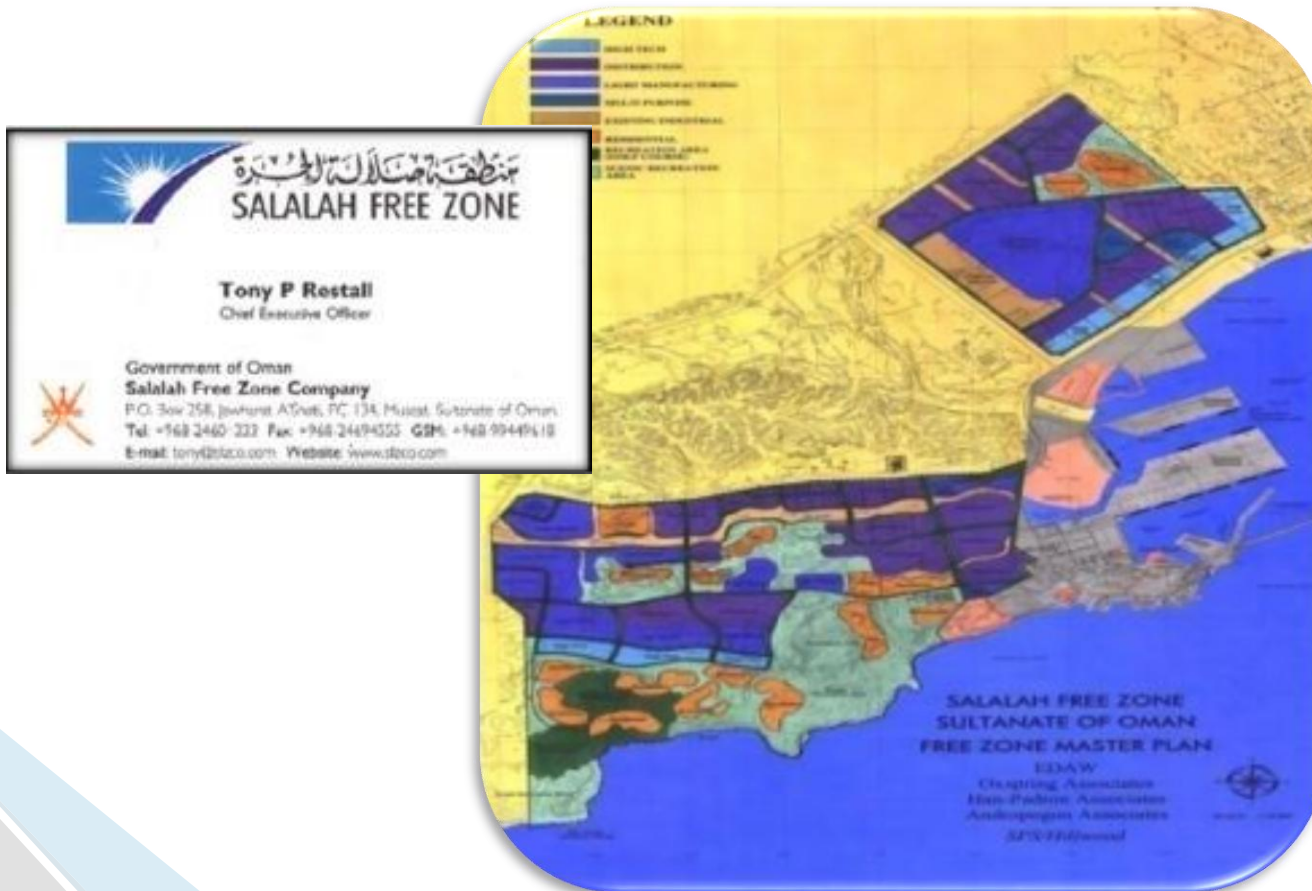
