(GDPR) Privacy Statement

For the purposes of the General Data Protection Regulation (“GDPR”) and the UK data protection laws, the controller is Jaegar Holiday Camp, 80 Grove Lane, London SE5 8SN.

About this document

This privacy notice sets out the way we process your personal data and we’ve created this privacy notice to make sure you are aware of how we use your data as a member of, or visitor to our club or to our website. This information is provided because Data Protection Law gives individuals rights to understand how their data is used. Staff and members are all encouraged to read this Privacy Notice and understand the Academy’s obligations to its entire community. This Privacy Notice applies alongside any other information the Academy may provide about a particular use of personal data, for example when collecting data via a paper form.

How we collect your information

We may collect your personal data in a few limited ways, namely:

- Directly from you,
- When you fill in an enrolment form
- When you fill out a taster form
- When you fill an enquiry form
- When you fill out a contact form.

The types of information we collect

We may collect the following types of personal data about you:

- Contact and communications information, including your contact details (including email address), date of birth, telephone numbers and postal address and records of communications and interactions we have had with you.
- Financial information, including direct debit details.
- Doctors details for your child in case of an emergency

We also collect the following information:

Whilst we do not generally collect sensitive information unless it is volunteered, we do specifically collect health data which will help assess your readiness for physical activity. We use this information provided by you, to assist us with your particular needs. By volunteering this information, you are consenting to us using it in the manner set out in this privacy policy.

Contacting J H C

When you contact Jaegar Academy via the website, email, post, phone or SMS, we collect, store and use certain information which you disclose to us. This may include name, address, telephone email or mobile number and other communication data. If you contact us, we may keep a record of that communication.

CCTV

Closed circuit television is installed at the camp for security reasons. If you have any questions about the use of CCTV in the club, please contact us directly. Notices about the use of CCTV are in evidence in and around the academy.

How we use personal data

Personal data provided to us will be used for the purposes set out at the time of collection and, where relevant, in accordance with any preferences you express.

More generally, we will use your personal data for the following purposes:

- Taking payment of fees.
- Communication about academy activities, changes to programme or information we think may be of interest to you.

How secure is information about me?

We maintain physical, electronic and procedural safeguards in connection with the collection, storage and disclosure of personally identifiable information. Our security procedures mean that we may occasionally request proof of identity before we disclose personal information to you.

Your marketing preferences

We will always respect your wishes in respect of what type of communications you want to receive from us and how you want to receive them. There are some communications, however, that we need to send you regardless of your marketing preferences in order for us to fulfil our contractual obligations to you as a member of the academy. Examples of these essential communications are:

- Records of transactions, such as payment receipts or direct debit confirmations (as applicable).
- Membership related mailings such as your membership renewal reminder, information about facility closures and opening hours.

Sharing your information with others

We do not sell or share your personal data for other organisations to use other than as set out below.

Personal data collected and processed by us may be shared with the following third parties, where necessary:

- Our employees, for the purposes of administering your membership, and giving you access to the membership benefits to which you are entitled.
- Our coaches.

How long your information is kept

We will keep your personal data only for as long as is necessary for each purpose we use it. For the majority of membership data, this means we will retain it for as long as you have a valid club membership and for a period of six years after your last interaction with the club (for accounting, record keeping and tax reporting purposes).

Website

Your internet browser has the in-built facility for storing small files – “cookies” – that hold information which allows the website to recognise your account. Our website takes advantage of this facility to enhance your experience. You can prevent your computer from accepting cookies, but if you do, certain functionality on the website may be impaired.

Your rights

Under certain circumstances, by law you have the right to:

- Request access to your personal data (“data subject access request”). This enables you to receive a copy of the personal data we hold about you and to check that we are lawfully processing it.
- Request correction of the personal data that we hold about you. This enables you to have any incomplete or inaccurate information we hold about you corrected.
- Request erasure of your personal data. This enables you to ask us to delete or remove personal data where there is no good reason for us continuing to process it. You also have the right to ask us to delete or remove your personal data where you have exercised your right to object to processing (see below).
- Object to processing of your personal data where we are relying on a legitimate interest (or those of a third party) and there is something about your particular situation which makes you want to object to processing on this ground. You also have the right to object where we are processing your personal data for direct marketing purposes.
- Request the restriction of processing of your personal data. This enables you to ask us to suspend the processing of personal data about you, for example if you want us to establish its accuracy or the reason for processing it. You can also withdraw your consent, where this is the basis for our processing your data (without affecting the lawfulness of our previous processing based on consent).
- Request the transfer of your personal data to another party.

Please note that the above rights are not absolute, and we may be entitled to refuse requests where exceptions apply.

Notices and Revisions

If you have any concern about privacy at Jaegar Academy, please email us (enquiries@jaegaracademy.com) and we will try to resolve the issue for you.

Our business changes constantly and our Privacy Policy and the website terms and conditions will change also. We may e-mail periodic reminders of our notices and conditions, unless you have instructed us not to, but you should check our website frequently to see any recent changes. Unless stated otherwise, our current Privacy Policy applies to all information that we have about you and your account.
