Explaining the legal bases Blackpool Wholesale Balloons relies on

The law on data protection, based on the General Data Protection Regulation and formerly the Data Protection Act, sets out a number of different reasons for which a company may collect and process your personal data, including:

Consent:

In specific situations, Blackpool Wholesale Balloons can collect and process your data with your consent. This may be when you have ticked a box to receive regular communications from him in a paper or electronic document or on our website

When collecting your personal data, Blackpool Wholesale Balloons always make clear to you which data is necessary in connection with a particular service.

Contractual obligations:

In certain circumstances, Blackpool Wholesale Balloons needs your personal data to comply with his contractual obligations.

If you have made a booking inquiry then Blackpool Wholesale Balloons will need your contact details for example.

When does Blackpool Wholesale Balloons collect personal data

When you visit this website

When you engage with Blackpool Wholesale Balloons on social media

When you contact Blackpool Wholesale Balloons by any means to make enquiries.

When you comment on or review Blackpool Wholesale Balloons.

What sort of personal data does Blackpool Wholesale Balloons collect?

Personal information including name, contact details and home address

Details of your interactions with Blackpool Wholesale Balloons such as with the website, email and social media

Copies of documents you provide Blackpool Wholesale Balloons or signed contracts

Payment information

Your comments and reviews

Your social media username, if you interact with Blackpool Wholesale Balloons through those channels, to help us respond to your comments, questions or feedback.

How Blackpool Wholesale Balloons will use your personal data and why

Of course, you are free to opt out of hearing from Blackpool Wholesale Balloons by any of these channels at any time.

To send you relevant, personalised communications by post or email in relation to updates, offers and services.

To perform any contract, Blackpool Wholesale Balloons agreed with you. If we don't collect your personal data during this process, we won't be able to provide the required services and comply with his legal obligations.

To respond to your queries or complaints

Handling the information, you sent enables Blackpool Wholesale Balloons to respond. We may also keep a record of these to inform any future communication with him and to demonstrate how we communicated with you throughout. We do this on the basis of our contractual obligations to you, his legal obligations and his legitimate interests in providing you with the best service and understanding how Blackpool Wholesale Balloons can improve our service based on your experience

To protect Blackpool Wholesale Balloons from fraud and other illegal activities. we'll do all of this as part of our legitimate interest.

Service messages will not include any promotional content and do not require prior consent when sent by email or text message. If Blackpool Wholesale Balloons does not use your personal data for these purposes, we would be unable to comply with our legal obligations.

To send you survey and feedback requests to help improve our service

How does Blackpool Wholesale Balloons protect your personal Data

Blackpool Wholesale Balloons knows how much data security matters to all his clients. With this in mind we'll treat your data with the utmost care and take all appropriate steps to protect it. His computer and mobile device are all password protected.

Blackpool Wholesale Balloons regularly monitor his systems for possible vulnerabilities and constantly review our security

How long will Blackpool Wholesale Balloons keep your personal data

Whenever Blackpool Wholesale Balloons collects or process your personal data, we'll only keep it for as long as is necessary for the purpose for which it was collected.

At the end of that retention period, your data will either be deleted completely or anonymised, for example by aggregation with other data so that it can be used in a non-identifiable way for statistical analysis and business planning.

Her Majesty's Revenue and Customs (HMRC) requires us to keep records of contracts, payments and invoices for 7 years. Blackpool Wholesale Balloons will therefore normally hold information of any contracts for this long.

Who does Blackpool Wholesale Balloons share your personal data with

Anyone required to do so by law such as the police.

Should that be necessary

Blackpool Wholesale Balloons provides only the information they need to perform his specific services.

Blackpool Wholesale Balloons may only use your data for the exact purposes we'll specify in our contract with them.

Blackpool Wholesale Balloons work closely with them to ensure that your privacy is respected and protected at all times

Where your personal data may be processed

Your data may be processed anywhere in the world including while using website features (i.e. forms) and Google Fonts.

This website is hosted in the United States.

You have the right to request

Access to the personal Blackpool Wholesale Balloons holds about you, free of charge in most cases

The correction of your personal data when incorrect, out of date or incomplete.

The right to deletion, for example when you withdraw consent, or object and Blackpool Wholesale Balloons have no legitimate overriding interest, or once the purpose for which we hold the data has come to an end (such as the end of a warranty).

That Blackpool Wholesale Balloons stops using your personal data for direct marketing (either through specific channels, or all channels).

That Blackpool Wholesale Balloons stops any consent-based processing of your personal data after you withdraw that consent

You have the right to request a copy of any information about you that Blackpool Wholesale Balloons holds at any time, and also to have that information corrected if it is inaccurate

To ask for your information, please contact Blackpool Wholesale Balloons on supply contact details.. If Blackpool Wholesale Balloons decides not to action your request we will explain to you the reasons for our refusal

Your right to withdraw consent

Whenever you have given Blackpool Wholesale Balloons your consent to use your personal data, you have the right to change your mind at any time and withdraw that consent.

Where Blackpool Wholesale Balloons relies on our legitimate interest.

In cases where Blackpool Wholesale Balloons I is processing your personal data on the basis of our legitimate interest, you can ask him to stop for reasons connected to your individual situation. We must then do so unless we believe to have a legitimate overriding reason to continue processing your personal data

Direct marketing

You have the right to stop the use of your personal data for direct marketing activity through all channels, or selected channels. Blackpool Wholesale Balloons must always comply with your request.

Contacting The Regulator

If you feel that your data has not been handled correctly, or you are unhappy with Blackpool Wholesale Balloons' response to any requests you have made to him regarding the use of your personal data, you have the right to lodge a complaint with the Information Commissioner's Office (ICO). You can contact them by calling 0303 123 1113 or go online to www.ico.org.uk/concerns

If you live outside the UK

By using Blackpool Wholesale Balloons' services or providing your personal data to him, you expressly consent to the processing of your personal data by him or on his behalf. Of course, you still have the right to ask him not to process your data in certain ways, and if you do so, we will respect your wishes

Sometimes Blackpool Wholesale Balloons will need to transfer your personal data between countries to enable him to supply the goods or services you've requested. In the ordinary course of business, Blackpool Wholesale Balloons may transfer your personal data from your country of residence to ourselves and to third parties located in United States.

By dealing with Blackpool Wholesale Balloons, you are giving your consent to this overseas use, transfer and disclosure of your personal data outside your country of residence for our ordinary business purposes. This may occur because his information technology storage facilities and servers are located outside your country of residence and could include storage of your personal data on servers in the United States.

Blackpool Wholesale Balloons will ensure that reasonable steps are taken to prevent third parties outside your country of residence using your personal data in any way that's not set out in this Privacy Notice. Blackpool Wholesale Balloons also make sure he adequately protect the confidentiality and privacy of your personal data
