Van Ownership Program

Fund a custom-built campervan. We operate it as part of our Okinawa fleet for 3 years. You earn monthly returns and receive the van at contract end — investment fully recovered.

Based on real van owner performance data from our Okinawa fleet, this program is on track to return 100% of the initial investment over the 3-year contract period.

01

Choose your van

Select from our custom campervan range. Each build is priced and revenue-modelled so you know exactly what to expect.

02

Fund the build

Pay the upfront cost. We handle all conversion, registration, and legal requirements under Japanese law.

03

We operate it

Your van joins the Evertrail fleet. We manage all bookings, guests, marketing, cleaning, and insurance.

04

Monthly returns

Every month we pay you 30% of gross rental revenue with a full transparent monthly statement.

05

Receive your van

After 3 years the van is legally yours. Keep earning with us, sell it, or explore Okinawa yourself.

FREQUENTLY ASKED QUESTIONS

Do I need to be a Japan resident?

Not necessarily, though ownership structures may vary by visa status. Many of our clients are foreign expats living in Japan.

How is the 30% calculated?

Based on gross rental revenue your van generates each month, before Evertrail operating costs. A transparent statement is sent every month.

Who pays for maintenance and shaken?

Routine maintenance and shaken (vehicle inspection) are the owner's responsibility. All insurance is fully covered by Evertrail.

What if my van is damaged?

Evertrail holds comprehensive insurance for the full contract. Damage caused by guests is handled through our insurance and deposit systems.

Can I exit the contract early?

Early exit can be discussed case by case. At contract end you're free to sell, continue renting, or keep the van personally.

What builds are available?

From compact Kei-class conversions to larger premium setups — each with its own projected revenue profile. Contact us for availability.
