

Iowa Catholic Radio Sweepstakes Rules

- No gift or pledge is necessary to enter or win a drawing. A gift or pledge will not increase your odds of winning.
- Unless otherwise specified, there is a limit of one entry per person during any contest. Participants with multiple entries may be disqualified.
- Only one qualifier or winner per immediate family within a 30-day period, unless otherwise specified.
- Each respective contest will have valid entry dates, and typically end on the date of drawing a winner.
- Unless otherwise specified, method of contest entry will usually require entry online through Iowa Catholic Radio's web site: www.iowacatholicradio.com, Facebook, etc. Iowa Catholic Radio staff cannot assist contest entrants (by, for example, completing entry online) who do not have web access.
- The decision of Iowa Catholic Radio staff in choosing the winner(s) will be final.
- Iowa Catholic Radio is not responsible for problems occurring within the telephone system, online deliveries, or mail/shipping deliveries which either inhibit or increase the chances of winning a contest. In case of problems like these, the decision of Iowa Catholic Radio will be final.
- In the event of a tie, two prizes will not be awarded. A tie will be broken by random drawing from among the tied qualified entries. The drawing will be conducted by Iowa Catholic Radio and the results of the drawing are final.
- Iowa Catholic Radio staff will directly contact any contest winner(s). All prizes, unless otherwise specified, must be picked up within thirty days of winning, Monday-Friday during normal business hours at the Iowa Catholic Radio studios: 2900 Westown Parkway, Suite 220, West Des Moines, IA 50266. It is the responsibility of the winner to claim the prize within 30 days of winning.
- If a prize is mailed, Iowa Catholic Radio is not responsible for any delays in receipt of prizes caused by the mail system.
- Winners may be required to sign a release, and all winners agree to allow Iowa Catholic Radio to use their name and/or likeness for promotional purposes without further compensation. All phone calls coming into Iowa Catholic Radio may be recorded and may be aired on Iowa Catholic Radio without further approval.
- Employees and agents of Iowa Catholic Radio, Iowa Catholic Radio Foundation, St Gabriel Communications, Trinity Communications, contest sponsor(s), and their families or representatives are ineligible to enter or win contests.

- Iowa Catholic Radio reserves the right to revoke prizes if the winner does not meet any or all eligibility requirements, even though an announcement may have been made indicating that person was the winner.
- Winners may not request substitution or other consideration from the originally awarded prize.
- Prizes are non-transferable and have no cash value, expressed or implied.
- A 1099 MISC form will be completed and filed with the Internal Revenue Service for each winner who, over the course of the calendar year has won prizes with a total value of \$600 or more. All local, state and federal taxes are the sole responsibility of the winner.
- Iowa Catholic Radio may, due to any unavailability of prizes, substitute another prize of equal or greater value for the prize originally won.
- Iowa Catholic Radio will not be responsible or be held liable for prizes awarded to an event that is canceled due to circumstances beyond our control.
- With respect to any disputes, the decision of Iowa Catholic Radio will be final.
- Iowa Catholic Radio, its agency, and representatives shall not be liable for any claim, injury or damage from any Iowa Catholic Radio contest, or prize awarded in a contest.
