

Iowa Catholic Radio Listener Survey Giveaway

Official Rules

NO PURCHASE, DONATION, OR FINANCIAL CONTRIBUTION IS NECESSARY TO ENTER OR WIN. A PURCHASE OR DONATION WILL NOT INCREASE YOUR CHANCES OF WINNING.

This promotion is intended to comply with all applicable federal regulations, including FCC regulations governing Noncommercial Educational (NCE) broadcast stations, and applicable Iowa state law.

1. Sponsor

This giveaway is sponsored by Iowa Catholic Radio, located in Des Moines, Iowa (“Sponsor”).

2. Eligibility

The giveaway is open to legal residents of the United States who are eighteen (18) years of age or older at the time of entry.

- The following individuals are not eligible to win:
- Employees, contractors, board members, and volunteers of Iowa Catholic Radio
- Immediate family members (spouse, parents, children, siblings) of the above
- Persons residing in the same household as any of the above
- Void where prohibited by law.

3. Contest Period

The giveaway begins upon posting and promotion of the Listener Survey and ends at 11:59 PM Central Time on March 19, 2026.

All entries must be received by the deadline to be eligible.

4. How to Enter

Participants may enter by completing the official Iowa Catholic Radio Listener Survey available at:

Limit one (1) entry per person during the contest period. Duplicate or automated entries will be disqualified.

- No purchase, donation, pledge, or financial contribution is required to enter or win.
- Completion of the survey with name and contact information provided constitutes entry into the giveaway.

5. Prizes

One (1) Grand Prize:

\$250 Visa Gift Card

Ten (10) Secondary Prizes:

\$25 Visa Gift Cards

Total approximate retail value (ARV): \$500.

Winners will be selected in a random drawing conducted by Iowa Catholic Radio from all eligible entries received during the contest period.

The drawing will occur on or before March 25, 2026.

7. Winner Notification & Forfeiture

Winners will be notified using the contact information provided in the survey submission.

Each winner will have seven (7) calendar days from the date of notification to respond and claim their prize.

If a winner:

Fails to respond within seven (7) days

- Is determined to be ineligible
- Cannot be contacted after reasonable attempts

The prize may be forfeited and an alternate winner selected at Sponsor's discretion.

8. FCC Noncommercial Educational (NCE) Compliance

This promotion is conducted by a federally licensed Noncommercial Educational (NCE) radio station.

The giveaway is not conditioned upon the making of any donation or pledge.

Donations to Iowa Catholic Radio do not improve chances of winning.
