A letter giving notice to correct a violation will be sent to the homeowner with the violation. Thereafter the above schedule is in effect. The homeowners must correct the violation or apply to the Board or AACC Committee with a written plan to correct the violation.

The notices serve as a determination that a Covenant violation has occurred. This determination is final unless you appeal to the Board by contacting the Board Secretary Patricia "Trish" Norman at <a href="mailto:kentonfirs@gmail.com">kentonfirs@gmail.com</a> OR in writing at 10605 SE 240<sup>th</sup> ST. #653, Kent, WA. 98031 within 10 days of the date the notice was issued to set a hearing date with the Board of Directors. At that time, you will be allowed up to a minimum of 30 minutes to explain the circumstances regarding the violation. If we do not hear from you in the manner indicated above, the Board will accept that you are waiving your rights to a hearing.

If we send the notice letters by certified mail, the homeowner is responsible for the cost of the certified letter. If the violation(s) are not corrected, or a written plan submitted and accepted by the Board or AACC Committee, then the matter may be turned over to the Association's legal counsel for enforcement of the covenants and/or collection of any unpaid fines and other fees/costs. Owners are responsible for all attorneys' fees and costs incurred in connection with enforcement of the covenants and/or collection of delinquent assessments, fines, and other fees. This schedule of Protective Covenant violation fines and late charges supersedes all prior schedules.
