She turned to the cameras, plastering a fake smile back on her face.



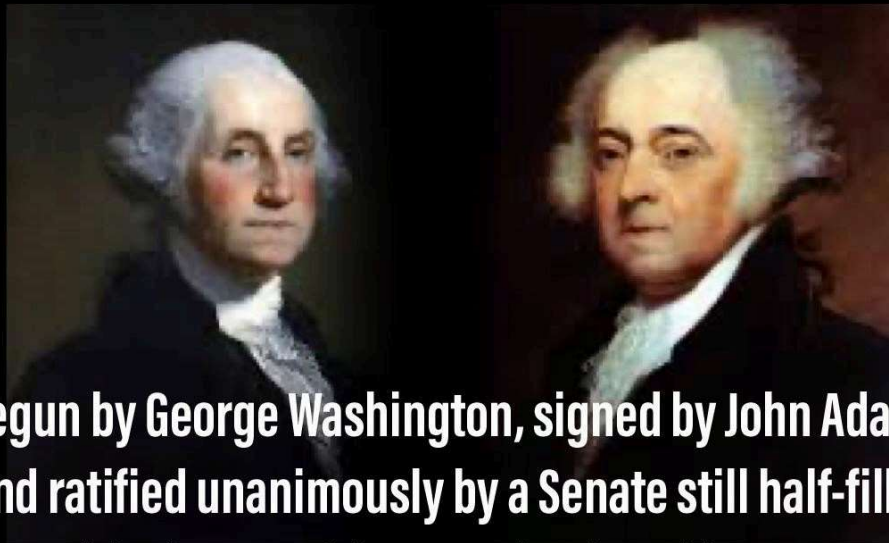
"Thank you, everyone! We'll have more updates soon!" Then she stormed off the stage, binder in hand, muttering expletives under her breath.
