

#### **General Instructions**

#### A. Bid Procedure

## (1) Bid Submission

Bids will be received by the SFJDWC until **3** *p.m.* PST on <u>Wednesday, October 8th, 2025</u> for the purpose of Abbott Juniper Removal

Bids received after the date and time stated above will not be considered.

<u>Project Timeline</u>: October 13<sup>th</sup>, 2025 – December 31<sup>st</sup>, 2027. Access to the site will be limited during hunting seasons.

#### (2) Bid Response Procedures

The response must be made on the provided "Bid Response Form". The signature of the bidder supporting the bid must appear in the space provided on page two (2) of this "Invitation for Bid" and the completed bid must be submitted in its entirety. Any deviations from these conditions may be considered sufficient justification to reject the bid.

Bid forms must be filled out in ink or other permanent means. All erasures and corrections must be initialed in ink. A legal authorized representative for the contractor must properly sign all bids.

# Telephone bids will not be accepted.

# (3) Pre-Bid Conference

A pre-bid conference and site tour will be held on **Wednesday, October 1<sup>st</sup>, 2025 @ 10:00 am**. Participants will meet at the Keerins Ranch Headquarters at 10:00 am PST. If you have any questions please contact Amy Stiner, 541-792-0435.

# (4) Clarification of Specifications

Any clarifications or protests to the specifications should be detailed in official correspondence to the Purchasing/Contracting Manager and be received five (5) days or more prior to the bid opening date. It shall be the sole responsibility of the bidder to understand all of the provisions of the bid invitation and contract specifications.

# (5) Clarification of Bid Responses



The Purchasing/Contracting Manager reserves the right to obtain clarification of any point in the firm's bid or to obtain additional information necessary to properly evaluate a particular bid. Failure of a bidder to respond to such a request for additional information or clarifications may result in rejection of that firm's bid.

## (6) Alteration of Bids

Bids may not be completed, amended, or clarified on the face of the bid after the official bid opening.

# (7) Time Bid Valid

All bids must be firm for 60 calendar days from the closing date of the bid.

## (8) Bid Award

The SFJDWC reserves the right to award the entire Project to one Contractor or divide the project and award to multiple contractors.

# (9) Certification for Debarment and Suspensions

This certification is required by the regulations implementing Executive Order 12549, Debarment and Suspensions, 34 C.F.R. Part 85, Section 85.510, Participants responsibilities. The regulations were published as Part VII of the May 26, 1988 Federal Register (pages 19160-19211). Copy of Certification attached as Attachment "A".

## (10) Insurance

Any contractor retained by the Council must provide proof of insurance before project work may begin. Unless this requirement is waived in writing by the Council, acting in its discretion.

**(11) Project Scoring:** SFJDWC is not required to select the lowest bidder. SFJDWC will base selection of CONTRACTOR upon the scoring table below.

#### **SCOPE OF WORK & SPECIFICATIONS:**

## **Abbott Juniper Removal**

#### 1. Descriptions of work:

The area known as Abbott is located on the Keerins Ranch, approximately 60 miles South of John Day. The South Fork John Day Watershed Council is hiring a contractor to perform 195 acres of Juniper removal, by either cut and pile or mastication. SFJDWC may hire one contractor to complete all project components or may hire multiple contractors to complete project work.

#### a. Contractor will:

<u>Juniper Removal:</u> All Juniper will be cut as close to the ground as possible, leaving no green material, and stumps less than 12 inches high. Removing remnant green material from stumps will be accomplished with loppers or chainsaws, if necessary. All seedlings should be cut or detached from the soil. All Juniper is to be removed, regardless of DBH, except for old growth juniper with asymmetrical and rounded tops, spreading and sparse canopies, dead limbs, and/or spiked tops, deeply furrowed reddish bark and the presence of bright green lichens on the stem and branches, and that are no longer producing berries will not be cut. Damage to native vegetation while felling or piling should be avoided.

**Mastication** is the preferred method of removal.

Juniper will not be piled on greater than 30% slope.

Machine piling is allowed when soils are dry, minimizing soil compaction/displacement damage to the soil.

Slash piles are not to exceed 20 feet (L or W) and 10 feet in height. Place piles away from favorable tree species (Ponderosa Pine) to prevent fire/heat damage.

Minimize Resource Damage: To minimize adverse impacts to surface soil and vegetation, contractor will ensure treatment does not begin until soils have dried and heavy machinery/chainsaw operators can perform work without causing damage. An estimated 6" or more rut will require the job be put on hold until the surface hardens.

<u>Oregon Department of Forestry Requirements:</u> Follow all Oregon Department of Forestry (ODF) State Fire Protection laws and requirements. Contractor needs to obtain applicable permits from ODF.

#### b. SFJDWC will:

Select contractor, develop contract, coordinate project, administer contract, flag units, supply maps, mark access road to project site, approve invoice(s) for payment, monitor contractor's compliance with the contract, review/approve minor contract modifications and changes which do not affect the contract price or substantially alter the scope of services.

**2. Work Site Location:** Abbott, Keerins Ranch, Oregon; Coordinates: 44.051184, -119.486935. The access road will be a private road through a locked gate. Access will be for work purposes only.

## 3. Planning:

a) Contractor will meet with the Project Coordinator as necessary to discuss progress, completion dates, and problems encountered as needed.

- **4. Permitting:** Operators Notification Permit from Oregon Department of Forestry and any other required permits.
- **5. Project Oversight:** SFJDWC
- **6. Trash Removal:** Contractor is responsible for removing any temporary facilities or trash resulting from the work.
- **7. Post Project Weed Washing:** Contractor shall wash all equipment leaving the job site, removing all noxious weed seeds.
- **8. Services and Materials Provided by Contractor:** All equipment, labor, transportation, and materials for project work which contractor has bid upon.
