Arun Joshi's *The Strange Case of Billy Biswas* offers a similarly deep examination of identity and spirituality, set against a modern Indian backdrop. It contrasts contemporary civilization with the innocence of tribal life, which is deeply rooted in Indian spiritual traditions. Billy's sense of alienation from a materialistic society and his eventual acceptance of tribal existence reflects Hindu concepts of renunciation (*Anāsakti*) and Buddhist detachment. As noted by one scholar, Billy's relationship with the tribal girl Bilasia represents "the human soul's yearning for reunion with the divine, as symbolized by Krishna, the merging

of 'Jeevātmā' with 'Paramātmā'. Billy's evolution into a tribal priest (mangod) and his spiritual abilities resonate with the Indian tradition of avatars, which are incarnations that connect the divine and human realms, illustrating a universal spirituality that goes beyond traditional religious boundaries.

The novels exhibit a common theme of disengagement from the ego and societal expectations, promoting self-exploration and empathy—concepts that are fundamental to numerous religions—thereby serving as powerful mediums for interfaith conversation. Siddhartha's path "from darkness to light" and Billy's rejection of "pseudo-western values" uncover critiques of materialism and highlight spiritual purity, enabling readers from various backgrounds to discover areas of empathy and common significance. Both works encourage readers to move beyond strict religious identities and recognize a more profound, interconnected spirituality, fostering mutual understanding and respect across different faith traditions.

2. Siddhartha – Functioned as Literary Bridge

The text states: "He must experience the unity and insight that concepts only point toward. He must find the truth for himself". This appreciation of individual spiritual journeys inspires readers from different traditions to honor a variety of paths and practices, promoting empathy for the experiences of others instead of strict adherence to doctrine.

Furthermore, Siddhartha's journey through various life stages—student, householder, ascetic, and ferryman—reflects the conventional Hindu ashramas while integrating Buddhist concepts of detachment and the middle path. The river, a key symbol, signifies the continuity and interconnectedness of all existence: "The river is everywhere at the same time, at the source and at the mouth, at the waterfall, at the ferry, at the current, in the ocean and in the mountains". This metaphor goes beyond religious limits, presenting a vision of interconnectedness that speaks to everyone, fostering reconciliation based on our common humanity and spirituality.

Siddhartha's profound insight—that true enlightenment is defined not by withdrawing from life but by wholeheartedly embracing and comprehending it—connects the divides between spiritual traditions that focus on either renunciation or active participation in the world. His insight, "I have always thirsted for knowledge... but now I understand that the wisdom we seek... must be learned through living, not listening or reading", challenges sectarian divisions and promotes **a pluralistic spirituality that honors multiple paths**. This synthesis allows Siddhartha to rise above its cultural and religious roots, transforming it into a timeless and cross-cultural instrument for enhancing interfaith understanding and harmony.

He has no love for the modern civilization... civilization is a monster" — poses critical inquiries regarding values, cultural disconnection, and the desire for spiritual unity. Through Billy's story, community dialogues can examine the tensions between contemporary and traditional viewpoints, fostering an appreciation for marginalized voices and the spiritual insights found within indigenous cultures.

Furthermore, both novels can serve as valuable resources in workshops or dialogue circles aimed at promoting interfaith understanding. The common themes of compassion, self-discovery, and interconnectedness they present create a foundation for participants from various faiths to contemplate universal moral and spiritual issues. For example, Siddhartha's river metaphor — "The river is everywhere at the same time, at the source and at the mouth...in the ocean and in the mountains" — can facilitate conversations about interconnectedness and our shared humanity, promoting reconciliation and empathy. Knowledge can be conveyed, it can be lived, it is possible to be carried by it, miracles can be performed with it, but it cannot be expressed in words and taught" [Hesse, *Siddhartha*].

This illustrates the Eastern focus on experiential knowledge that goes beyond language, aligning with Zen Buddhism's concept of directly addressing the mind without reliance on scriptures. At the same time, the wording and format cater to Western audiences who are familiar with a philosophical skepticism regarding didactic approaches and abstract concepts. Another important section is Siddhartha's contemplation on accepting the world's flaws:

“In my body and in my soul I realized that I greatly needed sin, I needed lust, vanity, the striving for goods, and I needed the most shameful despair to learn how to give up resistance, to learn how to love the world... to let the world be as it is, and to love it and to belong to it gladly” [Hesse, *Siddhartha*].

In this work, Hesse combines Hindu concepts of acceptance and Buddhist detachment with a Western existentialist appreciation for the contradictions of life—similar to Nietzsche’s idea of *amor fati*. This fusion promotes a perspective of spiritual maturity that emphasizes active participation in the complexities of life instead of retreating or succumbing to nihilism. The river serves as a recurring symbol, illustrating this blend: “Did you too learn that secret from the river: that there is no time? That the river is everywhere at once... and that there is only the present time for it, not the shadow of the past, not the shadow of the future?” [Hesse, *Siddhartha*]. The river metaphor illustrates the Eastern idea of eternal interconnectedness and transience, whereas the poetic narrative approach encourages Western literary admiration for metaphor and cohesive symbolism, rendering the spiritual message relatable and impactful for a wide audience.

Finally, Siddhartha’s profound spiritual awakening is articulated in a way that merges Eastern mystical oneness with Western reflective individualism: “Slowly blossomed, slowly ripened in Siddhartha the insight... the secret art of thinking, feeling and breathing thoughts of unity at every moment of life... harmony, knowledge of the eternal perfection of the world, smiling, oneness” [Hesse, *Siddhartha*]. This excerpt illustrates the non-dualistic wisdom that is fundamental to Hindu and Buddhist traditions, employing introspective and lyrical language typical of Western existential literature. It invites readers to merge personal reflection with universal spiritual principles. In these sections, Hesse intertwines Eastern spiritual concepts—experiential wisdom, impermanence, unity, detachment—with Western storytelling techniques—personal insight, poetic metaphor, psychological depth—to create a dialogue across cultures. This blend enhances the novel’s attractiveness, enabling it to serve as a powerful literary connection that surpasses borders, fostering empathy and comprehension among various religious and philosophical traditions. These combined sections affirm Siddhartha’s lasting significance as a piece that unites Eastern and Western perspectives, shaping a universal spiritual journey that is both accessible and pertinent to a diverse global audience.

Secondly, Joshi’s *The Strange Case of Billy Biswas* enhances this by highlighting the conflict between modern materialism and indigenous spirituality, echoing themes of alienation and a return to spiritual origins. Billy’s transformation and his acceptance by the tribal community align with Eastern philosophies of detachment and the cyclical essence of life, while the novel’s modern backdrop and psychological complexity utilize Western literary

realism. This duality allows readers to appreciate diverse spiritual frameworks, fostering interfaith dialogue and respect for cultural diversity.

The narrative techniques in the novels—including symbolic motifs like the river in *Siddhartha*, poetic language, and the portrayal of characters' psychology—successfully convey Eastern metaphysical ideas in ways that are understandable to Western readers. This blend allows the texts to act as catalysts for shared spiritual development by encouraging inclusive viewpoints and experiential knowledge instead of divisive doctrines. The incorporation of universal themes such as self-realization, compassion, and unity highlights their wide-ranging appeal and capacity for educational and community involvement.

By tackling these limitations, future studies can create a more thorough framework to utilize literature as an active catalyst for interfaith unity and shared spiritual development.
