AS PART OF THAT INITIATIVE, THE COALITION HAS PROVIDED RESOURCES, TRAINING OPPORTUNITIES AND EDUCATION TO THE ENTIRE SPACE COAST COMMUNITY. THE COALITION CREATED THE COUNTY'S OFFICIAL OPIOID ABATEMENT PLAN, A REQUIREMENT NEEDED IN ORDER FOR THE COUNTY TO RECEIVE FUNDS FROM THE FEDERAL SETTLEMENT WITH PHARMACEUTICAL COMPANIES PASSED DOWN TO THE STATES.
