Stanley Brizz is the Executive Director of Brevard Prevention Coalition in Florida and chairperson of Brevard County's opioid misuse task force. In addition, he is an addictions and substance misuse counselor for a regional medication assisted treatment (MAT) provider. Having lost his best friend to addiction and an overdose through drug poisoning, he has personal motivation to be a leader in the battle to reduce the losses from substance misuse in our communities and families.

Mr. Brizz has managed several substance misuse prevention initiatives in Brevard County as well as assisted in the rollout and management of initiatives with neighboring counties' coalitions in Florida. These included school-based programs, community-based programs and large-scale media campaigns designed to address substance misuse prevention, addiction and mental health.

Almost an entire generation of young people have been affected by drug addiction and alcohol misuse. Brevard Prevention Coalition is passionate about giving families and youths a chance to lead their best lives possible, as well as helping them avoid the pains and consequences of substance misuse and addiction altogether.

Our Mission, Vision & Values

At **Brevard Prevention Coalition, Inc (BPC)**, our mission is to cultivate a safe, welcoming, and prosperous environment on Florida's Space Coast, where residents can live, work, and enjoy recreational activities without the scourge of substance misuse. With a particular emphasis on reducing substance misuse among youths and throughout the broader community, we are committed to promoting positive life choices.



Our vision is to foster a resilient, healthier, and better-educated community that is free from the stigmas associated with substance misuse and addiction. In line with this vision, BPC actively engages in providing substance misuse prevention strategies, including organizing awareness events, conducting educational sessions, launching impactful media campaigns, and disseminating vital prevention resources, all aimed at building a future where individuals can thrive in a supportive and informed environment.

OUR HISTORY

Between 2007 and 2024, the Brevard Prevention Coalition, Inc. (BPC) underwent significant evolution and expansion in its mission to combat substance misuse in Brevard County, FL.

**2007-
2016**

A committee named Brevard Youth Substance Abuse Prevention Coalition (BYSAP) exists in the county for youth drug abuse prevention and underage drinking prevention. Stanley Brizz participates as a member and eventually becomes Chairperson.

2016

Collaborative efforts with other county coalitions in Central Florida commenced, aiming to address substance misuse through unified media campaigns under the direction of Central Florida Cares Health System, Inc.

2017

Partnerships with law enforcement and community organizations led to the formation of the Brevard County Opioid Misuse Task Force, facilitated by Brevard Prevention Coalition addressing education, treatment, and recovery.

2018

The committee becomes a 501(C)(3) nonprofit organization under the leadership of Stanley Brizz, now Executive Director, with the name Brevard Prevention Coalition, Inc. (BPC)

2022

BPC's initiatives expanded in 2022 with events like the Brevard Recovery Fest, challenging stigmas and raising awareness, as well as events under the I Choose ME, Move Into Light and Better Without It initiatives. Looking forward, BPC aims to enhance community engagement, expand prevention programs, and strengthen partnerships to combat substance misuse effectively.

**2023 -
2024**

BPC partnered with Brevard Public Schools, CTS Agency and Peace Club to create the Better Without It School Diversion Program to help students who initiated substance misuse, the first of its kind in the county. BPC also obtained national accreditation through Council on Accreditation (COA).
