



Attorney Action Plan — Strategic Roadmap

Objective: Maximize settlement leverage and prepare for trial readiness with minimal ramp-up cost and time.

Step 1: Records Consolidation

- Review case summary and timeline
- Obtain full operative report
- Confirm PT documentation/deposition availability
- Confirm second opinion records and expert opinion
- Pre/post-op imaging review

Step 2: Expert Witness Coordination

- Orthopedic expert to confirm standard of care deviation
- PT affidavit or deposition
- Optional: Biomechanical expert for gait analysis
- Vocational expert for earning capacity/loss
- Pain management specialist for chronicity and future care needs

Step 3: Damages Maximization

- Document economic damages with CPA or forensic economist
- Validate non-economic damages
