
The locations of Martins Bank, Lowick, Northumberland 1921 – 1969

The Berwick Advertiser dated 16 December 1921 announced that a sub-branch of the Bank of Liverpool and Martins, Ltd. has been opened at Lowick on Tuesdays. Mr C. W. L. Stevens, manager of the Berwick Branch, will be in personal attendance at Mr Stephen Mole's grocery shop, near the Post Office.



In October 1927 Stephen Mole put the shop and house on the market. Mr Renwick, possibly Thomas, bought the property. Moles Cash Stores continued to operate from the premises until Stephen's son, William, went bankrupt in 1937. He had to leave the property in February 1938. No mention of Martins Bank appears in the bankruptcy papers examined to date, so it is possible that the sub-branch had already moved to its new location, in what had once been the Golden Fleece, part of the Corner Shop.

On the right-hand side of the image below, the Victuallers sign can be seen above the doorway at the western end of the building in question. The second image shows the premises after the closure of the Golden Fleece in 1910.

John Mabon set up as a Baker on his own account at the Corner Shop, in 1924. In May 1937 he obtained planning permission to add another floor to the Bakery and Shop. The father of the late Tony Carr carried out the building work. It is not possible to tell whether the Bank was in situ at the time the image below was taken.

The branch closed in 1942 due to the shortage of staff and reopened after the war on 7 May 1946.

The last reference to the bank being open appears in the Martins Branch Directory called the *Green Book*, printed in the Summer of 1968. It possibly closed when Barclays took over Martins on 15th December 1969. [The take- over date was provided by an ex-employee of Barclays.]
