- Note 1 Personal information you provide will be held on the SDAA Ltd members register computer database and will not be passed on to any other organisation. If you provide phone numbers and/or an email address it will be assumed that you have no objection to these being used by the club to contact you.
- Note 2 Membership cards will not be valid unless a passport style ID has been securely attached.
- Note 3 Standard membership provides access to all SDAA waters, but does not include a night permit. Night Permits are required to night fish at The Airman, Broom Lake and Willington Lake.
- Note 4 The age limit for Junior Membership applications is restricted to persons who have reached the age of 12 but have not reached the age of 17. Juniors (aged 12-16) must be accompanied and supervised by a member aged 18 or over (authorised by a parent/guardian) occupying the same swim. The only exception is that Juniors will be allowed to fish unaccompanied in their own swim during the daytime, when a signed copy of the 'SDAA Junior Parent / Guardian Consent Form' has been processed by the Registrar (forms available from the SDAA website or by sending an SAE to the Registrar). All children under the age of 17 years can apply for **free** Associate Junior Membership (forms available from the SDAA website or by sending an SAE to the Registrar). Associate or by sending an SAE to the Registrar). Associate Junior Members can only fish with a single rod when supervised by a member aged 18 or over occupying the same swim. Associate Junior Members cannot vote at the AGM.
- Note 5 Keys stamped 'A11' are required to open gates at The Airman, Broom Lake, Willington Lake, the parking area near Jordans Mill and the allotments at Little Paxton.
- Note 6 Please indicate which payment method you would prefer to use for your SDAA Ltd membership if your application is successful. Payment can be made by electronic bank transfer (Method A), or by cheque/postal order (Method B). We do not accept cash. **Please do not include payment with your application**, the Registrar will contact successful applicants with details of how to make payment along with a unique Payment Reference Number.
- Note 7 Membership applications must be made by posting this application form to the Registrar. Applications will only be processed if the official application form has been used. We will not accept or process any applications submitted by email. There is no need to include a stamped SAE, photos or payment with your application form. You can include: (i) a signed copy of the 'SDAA Junior Parent / Guardian Consent Form' to accompany applications for Junior membership applications; (ii) Associate Junior Membership application forms to accompany applications from applicants aged 18 or over.
