If a member in good standing of a Camp in the Sons of Confederate Veterans requests transfer to another Camp, the demitting Camp must execute the transfer form and return it to the admitting Camp within 30 Days. If such action is not performed, the member is automatically transferred at the end of 30 days.

A member of the Sons of Confederate Veterans who has charges pending against him at the Camp or Division level in a manner consistent with the Constitution of the Sons of Confederate Veterans is not permitted to be transferred to another Camp of Division, respectively, until all charges against him are disposed of. The member continues to have all the rights and privileges of a member in good standing. This action in no way implies that the member is not in good standing, but is meant to insure that the disciplinary actions guaranteed but the Constitution are carried out.

GENERAL ORDER # 2004-1 November 17, 2004

I. In order to prevent illegal proxy voting [as specified in Article XX, Section 6], the Commander-in-Chief has directed the following:

Any member who transfers between camps will be ineligible to serve as a delegate to the General Convention for either camp for a period of twelve (12) months.

Exceptions will be made for members who transfer to camps chartered within that twelve month period. Exceptions will be considered on a case-by-case basis for compatriots that can prove a verifiable change of residence of over 100 miles in distance. Applications for exception should be made to the Adjutant-in-Chief.

II. This order is issued under the authority of the SCV Constitution, Article VII, Section 1.

III. Camps are requested to notify all members of this order.
