CIFCI TOTO is a community-driven meme token that merges the virality of internet humor with the dynamics of decentralized investing.

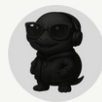
Designed as both a parody and a platform, CIFICITOTO reimagines the investor experience by making it entertaining, inclusive, and meme-powered.

# Tokenomics

## public supply :

The total public supply of \$TOTO is set at 70,000,000,000 tokens, ensuring ample availability to support the growth and sustainability of the CIFI TOTO ecosystem.






TOTO adopts a tiered presale pricing model designed to reward the early believers and builders of the community.

The presale will feature increasing price tiers, meaning the earlier you join, the cheaper the token. This encourages fast community onboarding and rewards those who take action early. Early presale participants not only enjoy lower token prices, but also enjoy enhanced rewards by TOTO, giving them a front-row seat to TOTO's investment journey.

"TOTO will launch with an initial community airdrop to ensure fair access from the very beginning. Following the airdrop, the token will enter a public presale until the maximum presale allocation of the total supply is reached. This model prioritizes transparency, inclusivity, and strong community foundations."

## Tokenomics and Distribution :

Community Airdrop (35%): Tokens allocated for building and engaging the TOTO community, supporting marketing initiatives, rewarding meme creators, and empowering TOTO art creators.

TOTO FUND (35%): The largest portion, representing tokens sold to early investors via sale.

Staking Rewards (10%): Tokens reserved to incentivize users to lock up their tokens (stake) to support the network and potentially earn rewards.

Investment (10%): The Investment allocation represents 10% of the total TOTO token supply and investing in early-stage tech-related projects. So its start for TOTO.

Liquidity Pool (10%): For Decentralized and centralized exchange liquidity.

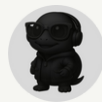
