## Background Information

---

- **‘Maa Ratanti Kalimata Cold Storage Private Limited’** was incorporated on 13.02.2014. It is classified as a Non-govt company and is registered at Registrar of Companies, Kolkata. The Corporate Debtor is engaged in the business of cold storage of agricultural produce.
- As per the Memorandum of Association (MoA), the main objective of the Company is – “To construct, build, equip, own and maintain and to carry on business as keepers of cold storage, storage chambers, ice-plants, godowns, warehouses, refrigerators, freezing houses, and room coolers for storing fish, sea foods, marine products and processed fish, meat, eggs, poultry products, protein foods, milk, cream, butter, cheese, bacons, sausages, fruits, roots, vegetables, all sorts of agro-based commodities, potatoes, fruits edible and similar goods or other substances made from all or any of them and canned, tinned and processed foods, or in any other form whatsoever and to act as buyer, sellers to deal in all sort of agro-based commodities, potatoes, fruits, vegetable, edible and similar good.”
- CIRP was commenced vide order dtd. 25.01.2024 by the Hon’ble NCLT Kolkata Bench and Mr. Samya Sengupta was appointed as the Interim Resolution Professional. Subsequently, vide order dtd. 27.06.2024 by the Hon’ble NCLT Kolkata Bench Mr. Santanu Brahma was appointed as the Interim Resolution Professional in place of the erstwhile IRP.
- The Hon’ble NCLT, Kolkata vide its order dtd. 22.08.2024 excluded 160 days from the CIRP period.
- On 06.03.2025, the Resolution Professional took handover the physical possession of the cold storage unit situated at Village + P.O Jaugram, P.S Jamalpur, Purba Burdwan, West Bengal 713166.
