

INTERNAL REGULATIONS -OSE 26-

The event dynamic SPICE EVENTS CHEER & DANCE, even if it has the status of an association, creates each year its international open named O.S.E. This remains private in terms of registration and entry fees. Any entity that has damaged the image of SPICE EVENTS may be denied access to registration and O.S.E. days, in order to ensure the smooth running of the event. Any refusal will be justified by presenting a very precise specification that we keep at your disposal.

ANY CLUB THAT HAS NOT FOLLOWED THE PRE-REGISTRATION REQUESTS WILL NOT BE GIVEN PRIORITY.

ONLY THE SPICE EVENTS STAFF VALIDATES THE FINAL REGISTRATIONS WHICH WILL BE CONFIRMED TO YOU ONLY BY RETURN OF EMAIL.

Each participating club is asked to take note of these rules of procedure and to inform any person likely to be present and to represent the participating club during the open O.S.E.

- -Any club that has not followed up or signed the contract for acceptance of the requested clauses, despite a good repute contract signed prior to the OSE 25 competitions, will not be eligible for a new award FOR OSE 26.
- -Any club that has not responded to the contracts sent for the implementation of competition passes over two years may be denied the right to participate in OSE 26. Our staff must keep their commitment to their partners, and failure to sign contracts and clauses can harm the sustainability of established agreements and penalize our future winners.

SPICE EVENTS is above all an initiator of opportunities for the participating athletes and wants to ensure unwavering credibility for them.

- ATTENTION REQUEST OSE 26:
- *Each participating club must make a volunteer available for the participation days on the Week at OSE 26. The dispatch will be carried out by our care according to the days of participation.
- *No club will be able to let its personal photographer enter the entire competition area. Our staff remunerates professional photographers and they alone have the right to the image pursuant to article 9 of the civil code.
- Any complaint regarding the report sheets will only be sent by email the day after the competition. No discussion or disturbance of the JUDGMENT staff will be possible.
- Only clubs that have paid the registration fees will have access to the AWARDS. The winning clubs of the previous year's opens will not be able to claim a pass /Bid/camp.... (including OSE & partners).

- it is STRICTLY forbidden to go on stage or to come against the judges. The area in front of the practicable area must not receive any person.
- No spectators will be accepted in the WARM U P & COMPETITIONS area, please convey the message to your athletes and parents.
- -Only the schedules of each team will be sent by email and no longer the complete schedules. And this, 3 weeks before the minimum D-day.
- A deposit is requested during the validation by the staff of the registration file. In view of the costs incurred and the implementation of logistics upstream for the organization of this open, no refund will be possible in case of a decree/decision made by an authority of any kind (State, prefecture, town hall...) as well as on withdrawal from the registered club.
- Please take note of the order of passage and follow the instructions in order to ensure a smooth progress.
- A direction of entry/exit traffic will have to be respected both in the competition areas and in the competition area.
- Particular attention is requested on the respect of appropriate shoes to put before entry on the apron, same for the dance slippers.
- No personal effects will be accepted on the competition surface, the effects must NECESSARILY remain in the warm-up area (it is also forbidden to drop one's belongings in the sitting area reserved for athletes near the competitive area), in order to ensure a quick and safe evacuation when needed.. An access and circulation plan inside will be posted and must be respected. The SPICE EVENTS staff declines all responsibility in case of theft and/or loss.
- It is strictly forbidden to sit on the edges of the practicable, no athlete shall exceed the indicated limits or move them: Please inform your athletes and staff supervising to sit in the places intended for this purpose.
- Please respect the passage of each team by disciplining your athletes. A check must be made by our staff before entering the passable.
- It is requested that the declared companions supervise their teams and ensure compliance with the internal regulations of the competition room.
- It is requested that coaches take into account the capacity and technicality acquired by their athletes for each routine. If this were not the case, the participating team could be disqualified
- It is requested that each manager knows how to locate themselves regarding emergency exits and the position of the rescue station. Professionals will be at your disposal if needed.
- It is requested that each team provide spotters to ensure the safety of their athletes during cheerleading and stunt routines. The staff will not provide staff for this purpose. The spotters will have to pay the ENTRY ZONE COMPETITIONS fees like everyone else.

- All athletes must maintain a spirit of 'fair play' during O.S.E: Any overflow as well as non-compliance with the regulations will result in permanent exclusion.
- Any person present within the O.S.E must not be under the influence of alcohol or drugs. If a suspicious behavior is identified, the exclusion will be effective directly. The staff reserves the right to call upon the security services in case of overflow.
- Only people with an ATHLETE bracelet handed in at the beginning of the open will be accepted into the athletes' area. Only people with a coach badge or bracelet will be accepted in the VIP lounge and COACHS area set up for the passages of their club's routines.
- -Mascots and spotters are not accepted in the coaches and VIP zones.
- The entries and meals of the bus drivers are the responsibility of the participating club.
- It is requested to have the appropriate attire to practice the disciplines.
- It is also forbidden to go shirtless or in underwear within the confines of the competition.
- Jewelry and piercings are completely prohibited.
- Athletes who start a routine must remain the same until the end. No changes during the routine will be accepted.
- An athlete can compete in different categories provided the level is different.
- The accompanying supervisors declared may not intervene on the passable area. A spot will be reserved for them during the routine of their athletes. It is STRICTLY FORBIDDEN to exceed the indicated limits. Only the seating places set up specially framing will be authorized.
- Only the coaches of each team are responsible for the non-presentation of their team in time before entry into the competition area. If the team is not present at the time indicated on the Schedules, they may be denied access to the prat.
- The horns of mists are totally forbidden in the concourse.
