Born into the physical through the sacred passage of Avaiki, through the union of mother and father, Bestowed with Te Kawa Mana Atua, the divine authority—empowered by the Creator, infused with His eternal DNA. I'O E Au—God in Me. I'O E Koe—God in You. I'O E Tatou—God in All of Us.

Through the SACRED SOVRAN-SOVEREIGN-SOVEREIGHTY ALLIANCE OF FIRST NATIONS—TE KAWA MANA ATUA—we stand at the threshold of destiny, fulfilling the calling of our chosen leaders and people from the spiritual realm to the physical divine blood lines through our ancestors. From the realm beyond, where souls are chosen for their sacred journey, we enter the physical world through a divine Ava-Iki, the divine passage of selection. By this anointing, we are entrusted with a purpose woven into the fabric of existence in I'O Matua Nui our creator.

**Avaiki-Nui**, Mother Earth, cradles our arrival and journey, guiding our steps as guardians of wisdom, sovereign protectors, and keepers of the ancestral flame *I'O E Au—God in Me. I'O E Koe—God in You. I'O E Tatou—God in All of Us*.

By the divine empowerment of **I'O Matua Nui, God Almighty**, we rise, illuminated by the light of prophecy, bound by the sacred covenant of unity, and carrying the eternal Karakia Pure Chants and song of our people across the lands and waters of **Te Moana Nui O Kiva**.

#### **Prophecy of Divine Unification**

"Should the three sacred colors—red, black, and white—pass through the eye of the needle, then shall the sovereign bloodlines be bound as one."

Thus, Meautara High Priest, Kahui Ariki, Mataiapo, Rangatira, and all Tama Tumu—E Tangata Māori, E Taata Maohi, E Kanaka Maoli—shall stand united, embracing the Sacred Alliance of our Island Nations:

**Avaiki-Runga, Avaiki-Tautau, Avaiki-Tauaro, Avaiki-Roa, Avaiki-Pamamao**—lands settled in divine purpose, more than a thousand years before the forceful forces of colonization imposed their will.

Yet, though the premeditated agenda of enslavement and genocide has sought to sever our inheritance since 1795 AD—its shadow stretching through time to this very year, 2025—we remain.

Our truth endures. Our sovereignty is unbroken.

The **EYE OF THE NEEDLE** is the threshold through which the chosen pass—a divine selection, a purification, a transfiguration of spirit into purpose. Only through this sacred passage may unity be restored, sovereignty affirmed, and prophecy fulfilled.

Red, the bloodline—ancestral strength, sacrifice, and the eternal pulse of life eternal. Black, the sacred foundation—the wisdom of the unseen, the depth of knowing, the guardianship of truth. White, the divine light—the purity of purpose, the anointing of creation, the call to oneness.

# **SACRED ALLIANCE FIRST NATIONS** falls under our ancient oral coding names herein **Sacred Calling of Divine Unification**

Through **I'O E Au**—God in Me, **I'O E Koe**—God in You, **I'O E Tatou**—God in All of Us, The Creator, Almighty I'O, calls forth unity.

As the three sacred colors converge within the passage, so too shall the nations rise in **ONENESS**, standing together as one people within **Avaiki-Nui**, **Te Moana Nui O Hiva**. #### Affirming Our Ancient Ancestry Through Oral History

We stand upon the foundation of sacred bloodlines, bound by ancestral wisdom and divine inheritance.

- AVAIKI-ROA Hawaiki Loa, known today as Turtle Island Nations (North and South America).
- AVAIKI-PAMAMAO The vast lands of Alkebulan (Africa), Atia-Uru-Upoko (Asia), India, and Te Urimaroa (Australia).

We do not accept the imposed identities of **Pacifica**, **Polynesia**, **Micronesia**, **or Melanesia**— for these are colonial distinctions that do not define us.

We stand in *COVENANT* with I'O Mātua Nui, the Eternal Creator, Honoring the sacred calling that binds the First Nations and First Island Nations in divine purpose.

Our first and everlasting agreement is the **Treaty of Peace**— A consecrated bond with **I'O Mātua Nui**, formed through sacred ceremonial inductions, Uniting sovran sovereign and sovereignty bloodlines, affirming our divine existence, and restoring our rightful place in creation. **The Path of Sacred Induction TE KAWA MANA ATUA.** 

- 1. **The Calling** A summons to tribal leaders and high priesthoods, to gather in unity, answer the divine call, and affirm the **Treaty of Peace** with our Creator.
- 2. **Purification & Anointing** The sacred cleansing of water and spirit, A consecration of leaders chosen to guide the **Sacred Alliance Nations** with wisdom and truth.
- 3. **The Covenant of Nations** An unbreakable treaty, binding all sovereign leaders and their people, forged through ancestral truth, upheld through divine Lore.
- 4. **Divine Recognition & Sacred Duty** The acceptance of our calling from **I'O Mātua Nui**, with full acknowledgment of the sacred responsibilities entrusted to us.

This <u>OATH</u> is undertaken by those ordained as: **Ariki, Mohi, Konohiki Ari'i, Taunga Meautara, Makaula Mataiapo, Rangatira, Elders**—within the sovereign domain of **Avaiki-Nui Te Koutu Nui Ariki Sovran Island Nation**, Carrying forth the unbroken lineage of **E Tama Tumu No Te Fenua Māori, Taata Maohi, Kanaka Maoli, Te Fenua Avaiki-Nui Te Moana Nui O Hiva**.

This <u>SACRED VOW</u> TE KAWA MANA ATUA is sealed through Karakia, sacred prayer to: I'O Mātua Nui— The Supreme Source, The Creator of All, I'O Tama Ariki Nui—The Divine Ruler and Sacred Authority, I'O Te Vairua Tapu Nui—The Holy Spirit, The Eternal Breath of Life.

Thus, by **SOLEMN OATH**, we affirm our sacred duty, our sovereign inheritance, and our eternal bond with the Creator.

#### 1. Affirmation of Sacred Unity

All signing members of the **Sacred Alliance of First Nations and Island Nations**, representing diverse tribal nations—including Elders, Priesthoods, Meautara, Makaula, Matakite, Mareikura, Te Koutu-Nui Kahui Manukura, Ariki-Nui, Mohi, Konohiki Alii, Mati, Mataiapo Tutara, Rangatira, and all recognized holders of hereditary titles—solemnly declare: **"TE KAWA MANA ATUA"**—the sacred covenant of divine sovereignty.

#### 2. Sealing the Sacred Vow

The vow of **TE KAWA MANA ATUA** shall be consecrated through *Karakia* (sacred prayer), calling upon:

- I'O Mātua Nui—The Supreme Source, The Creator of All
- I'O Tama Ariki Nui—The Divine Ruler and Sacred Authority
- I'O Te Vairua Tapu Nui—The Holy Spirit, The Eternal Breath of Life

Through divine atonement, we receive spiritual restoration and establish this eternal peace covenant with our Creator, **I'O Mātua Nui** 

#### **Article Two:**

#### **Ceremonial Obligation of Sacred Induction**

The unification of sovereign tribal nations under the **Sacred Alliance of First Nations and Island Nations** is consecrated through sacred ceremonial rites, affirming our divine purpose in the presence of **I'O Mātua Nui**—the Supreme Source, the Divine Architect of Life.

#### 1. Invocation of Ancestral Authority

Each sovereign leader, elder, and titleholder shall undergo **ritual induction**, sealed through the sacred rites of *Karakia* (prayer), **Tapu** (sacred consecration), and I'O Tama Ariki Meautara (authority affirmation), ensuring alignment with divine will and ancestral wisdom by cleansing in the water of lie.

#### The Covenant of Divine Alignment

By entering this **sacred vow**, all members pledge:

Author; Paramount Chief; Tinokura Te Ariki Taraare

- To uphold divine order through their role as custodians of sovereignty.
- To honor ancestral wisdom passed through oral traditions and prophetic guidance.
- To engage in sacred communion—invoking the Creator's presence through ceremonies, prayers, and spiritual observances that reinforce harmony and unity.

#### 3. Spiritual Consecration of Leadership

Every sovereign leader within the Alliance shall undertake the sacred obligation to:

- Participate in **ceremonial blessings**, calling upon **I'O Te Vairua Tapu Nui**—The Holy Spirit, The Eternal Breath of Life.
- Receive the **Kawa Mana Atua**, the divine mantle of sacred guardianship, sealed in the presence of fellow tribal representatives and witnessed by sacred elders.

- Offer sacred prayers (Karakia) and chants, allowing the voice of the people to be woven into the fabric of divine sovereignty.
- Contribute through traditional arts, storytelling, and symbolic expressions, preserving the sacred narratives that define their heritage.

Through community participation, every member of the Alliance becomes an integral part of the sacred covenant, ensuring that leadership and sovereignty remain deeply rooted in the voices, traditions, and spiritual essence of the people.

#### **ARTICLE THREE:**

# Self-Determination and Nation-Building Partnership Agreement Declaration of Sovereign Authority:

We, the signing members of the Sacred Alliance of First Nations and Island Nations— representing diverse tribal nations, including Elders, Priesthoods, Meautara, Makaula, Matakite, Mareikura, Te Koutu-Nui Kahui Manukura, Ariki-Nui, Mohi, Konohiki Alii, Mati, Mataiapo Tutara, Rangatira, and all recognized holders of hereditary titles—solemnly affirm:

- 1. That we stand as mature and unified leaders, prepared to activate our sovereign authority— Te Kawa Mana Atua—in sacred partnership.
- 2. That as the Sacred Alliance of First Nations and First Island Nations, united under Avaiki Nui Te Moana-Nui-O-Hiva, we uphold our inherent capacity for self-determination, governance, and nation-building.

#### Sovereignty:

- Ancestral Authority: Emphasizing the legitimacy of governance through lineage and sacred stewardship.
- **Self-Determination:** Affirming the inherent right to govern without external interference.
- **Oral Histories as Legal Framework:** Strengthening the recognition of oral traditions as sovereign evidence in governance and legal matters.
- **Spiritual and Celestial Mandate:** Positioning sovereignty as not only cultural but divinely guided, reinforcing prophetic alignment.

- 1. **Historical Subjugation and Control** The documented history of imposed rule, systemic exploitation, and criminal offenses committed against sovereign nations.
- 2. **Intentional Depopulation Policies** Decades of strategies aimed at diminishing indigenous populations and erasing cultural identity.
- 3. **Unaccountable Global Entities** The actions of unelected organizations, including the WHO, which have dictated policies without consent or representation.
- 4. **Military-Industrial Exploitation** The continued use of militarized power structures to suppress indigenous sovereignty.
- 5. **Government-Corporate Collusion** The alignment of governing bodies and corporate entities in historical and ongoing exploitation and criminal activities.

#### **Basis of Non-Compliance with External Laws**

We reject all externally imposed mandates that have been designed to subjugate, harm, or eliminate indigenous populations through:

- Historical crimes against humanity, including genocide, slavery, forced assimilation, and cultural erasure.
- **Confirmed harmful policies**, including the forced administration of health interventions and economic manipulation.
- Weaponization of environmental and health systems, including geoengineering, industrial pollution, and mass health directives without consent.
- Human Trafficking our children and people are being used for organ, blood, and sex exploitation by the system.

- Any government, corporate, or institutional act—such as nuclear waste dumping, chemical land testing, geoengineering cloud manipulation, or concealed militaryindustrial bases—shall be deemed a direct offense against First Nations and First Island Nations sovereignty. Such violations shall be formally prosecuted under international law as acts of war and ecological genocide, with reparations sought through the World Court.
- 2. Any enforced medical interventions—including mass health directives issued by the World Health Organization (WHO), the World Economic Forum (WEF), or government agencies—shall be rejected in full by the Councils of Chiefs. The forced or deceptive deployment of vaccines upon Sacred Alliance First Nations and First Island Nations shall be classified as genocide under the Geneva Convention and international humanitarian law.
