

Ambassador Agreement

Purpose: The purpose of this Ambassador Agreement (the "Agreement") is to ensure that all Ambassadors of the World Wellness Route & the World Wellness Ranking (the "Organization") understand and agree to adhere to the highest standards of ethical conduct, professional behavior, and the guidelines set forth in the World Wellness Route & World Wellness Ranking Ambassador Handbook. This Agreement outlines the expectations for Ambassadors in their interactions with the Organization, its members, partners, and the public.

As an Ambassador, I agree to the following:

1. Adherence to Handbook: I have read, understood, and agree to comply with all the terms, conditions, guidelines, and expectations outlined in the most recent version of the World Wellness Route & Ranking Ambassador Handbook. This includes, but is not limited to, the sections on:

- o Role Overview
- o Ambassador Requirements
- o Duties and Functions
- o Advantages and Benefits
- o Economic Rewards
- o Term and Renewal
- o Ambassador Kit
- o Ambassador Agreement

2. Integrity: I will act with honesty, transparency, and integrity in all my dealings as an Ambassador. I will not engage in any activities that may compromise the integrity of the Organization or my role as an Ambassador.

3. Respect: I will treat all individuals with respect, fairness, and dignity. I will not discriminate against anyone based on their race, ethnicity, gender, sexual orientation, religion, age, disability, or any other protected characteristic.

4. Professionalism: I will conduct myself in a professional manner at all times. I will be punctual, prepared, and responsible in fulfilling my duties as an Ambassador.

5. Confidentiality: I will maintain the confidentiality of any sensitive information I may encounter in my role as an Ambassador. I will not disclose such information to any unauthorized parties.

6. Compliance: I will comply with all applicable laws, regulations, and the Organization's policies and guidelines.

7. Conflict of Interest: I will avoid any conflicts of interest between my personal interests and my responsibilities as an Ambassador. I will disclose any potential conflicts of interest to the Organization in a timely manner.

8. Use of Resources: I will use the Organization's resources, including its name, logo, and materials, responsibly and only for authorized purposes.

9. Representation: I understand that I am a representative of the Organization, and my actions and statements reflect upon the Organization's reputation. I will strive to represent the Organization in a positive and professional manner.

10. Economic Rewards: I acknowledge and agree to the Economic Reward structure as detailed in the current Ambassador Handbook. As an Ambassador, I understand and accept that the Organization reserves the right to adjust the terms and percentages of this Economic Reward at any time, with notification provided to me.

11. Intellectual Property: I acknowledge that all intellectual property, including but not limited to trademarks, copyrights, and logos, associated with the World Wellness Route & World Wellness Ranking, its programs, and its materials, is owned exclusively by the Organization. This Agreement does not grant me any license or ownership rights to use the Organization's intellectual property, except as expressly

authorized in writing by the Organization. Any use of the Organization's intellectual property must be in accordance with the Organization's guidelines and policies.

12. Accountability: I will be accountable for my actions and decisions as an Ambassador. I will be open to feedback and willing to address any concerns or issues that may arise.

13. Consequences of Violation: Any violation of this Agreement, including non-compliance with the Ambassador Handbook, may result in disciplinary action, including but not limited to:

- Verbal or written warning
- Suspension of Ambassadorial duties
- Termination of the Ambassadorial role
- Legal action, if applicable

14. Governing Law and Jurisdiction: I agree that any legal action or proceeding arising out of or relating to this Agreement shall be governed by the laws of the state and country selected by the Organization, and that the exclusive jurisdiction for such action or proceeding shall be in the courts located at the place designated by the Organization.

By its signature below, the World Wellness Route hereby accepts the terms and conditions of this Ambassador Agreement and agrees to be bound by its provisions.

Acceptance and Subscription by the Ambassador: By completing the registration process and/or by their electronic or written signature below, the Ambassador hereby acknowledges that they have read, understood, and agree to be bound by all the terms and conditions of this Ambassador Agreement and hereby subscribes to its provisions.
