

PRIVACY POLICY

It is the policy of AG Fertil Corporation and AGfertil.com (collectively herein referred as "AGfertil.com" and/or "We") to respect the privacy of its online visitors. The purpose of this "Privacy Policy" is to tell you how we collect, store, use, and share information about you when you visit or use online services offered by AGfertil.com or its affiliates that link to or reference this Privacy Policy.

Types of information AGfertil.com collect and how we use this information?

1. We collect non-personal information about online visitors in order to improve your online experience.
